## ‘Krishna Ghati’ Hero remembered

UDHAMPUR: A function was organized by 'Krishan Singh Memorial Welfare Committee-Uliian' (KSMWC) to pay floral tributes and to remember the sacrifice of 'Krishna Ghati' (Poonch) Hero Shahid Krishan Singh Jamwal, 'Vir-Chakra' awardees, at 'Shardhanli Sthal' Udhampur. Briefing the media, President of the committee Mahadeep Singh Jamwal (Rtd SSP) said that on the intervening night of 15/16 July 1948, an army picket at Poonch sector was captured by the Pak army. A contingent under the command of Subedar Krishan Singh of 8th JAK Rifle was assigned the task to liberate the said picket and in a bayonet fighting with the Pak Army soldiers, the said picket was recaptured. But in the scuffle Subedar Krishan Singh and one of his colleagues Sepoy Bua Ditta lost their lives. Recognizing the bravery of both the martyrs, Government of India awarded them 'Vir-Chakra', the third in precedence in wartime gallantry awards, posthumously in 1948. The place where martyrs laid their life is christened as 'Krishna Ghati' in the name of Subedar Krishan Singh. This healthy practice of paying homage to martyrs spread a larger message to the society that our martyrs are the National Hero in real sense, who laid their life for the sake of the country to provide the countrymen a happy living Jamwal said. Large congregation hailing from across the civil society, NGOs, All India ex-service league members with their vice-President Dalbir Singh, members from 'Ex-Serviceman Kalyan Kari Sangthan' and its President Baan Singh, vice President Krishan Chand, members of 'Senior Citizens' Club (Regd) along with Col (Rtd) Balwant Singh vice-

President, Romesh Kumar, Ravi Kumar, Mohan Singh, Vijay Kumar, Chaggar Singh from advisory board of the club, business men across the society attended the function and paid floral tributes to the martyr.
