Wednesday seized 8 dumpers , 2 trolleys and arrested 2 accused persons.

As per details, a complaint has been received to Reasi Police that some dumpers are involved in theft of mining material in Anji Khad area Block No. 06.

On this complaint a party from Police Station Reasi rushed to the spot and nabbed 2 persons from the spot who was involved in theft of mining material from that area.

The police also seized one dumper bearing registration number JK20 B 1837 loaded with stolen mining material. In this regard case FIR No. 146/2023 under section 379 IPC and 3/4 PDPP Act has been registered at Police Station Reasi.

In another incident, team of Police Post Dera Baba also seized one trolley bearing Registration No. JK02CX7263 with illegal mining material at Balini Nallah. While team of Police Station Armas also seized a tractor trolley without registration number with illegal mining material near the bank of River Chenab.

In another incident, team of Police Station Katra seized 05 dumpers JK14E-1155, JK14T-1155, JK14C-9367, JK14H-9755, JK20B-8989 for violating mining norms , while a team of Police Station Mahore also seized 02 dumpers JK20B-4106 , JK11F-3351 who was carrying illegal mining material.

Woman among two thieves arrested, stolen items worth 1.2 lakh recovered

REASI: Police on Wednesday solved a theft hours in few hours by arresting two thieves including a woman and recovered stolen items worth 1.2 lakh.

As per details, a complainant namely Milan Kumar, son of Rakesh Kumar, resident of Thandi Khassi Rajouri comes to Police Station Bhawan with a written complaint that he locked his belongings inside locker located at locker room and went for Darshans. After returning back, he found his lock broken and belongings missing. In this regard a case FIR 12/2023 registered and investigation started.

After zeroing few suspected and by technical assistance the stolen items worth more than Rs 120,000 recovered in FIR No 12/2023 under section 379/IPC of Police Station Bhawan and recovery was made from accused namely Balvinder Singh, son of Harmek and Saroj, wife of Jagdish both resident of Anupgarh, Ganganagar, Rajasthan. Recovered Items include 06 Mobile phones.

The recovery and arrest was made out by police team led by SHO Khyati Maan accompanied by PSI Raghav Chalotra.

Forest team Range seizes illicit deodar timber

BILLAWAR: Forest Team Billawar on Wednesday seized illicit deodar timber


As pr details, acting on specific inputs from reliable sources, a team of Forest officials headed by the Range Officer, Billawar Range and another team headed by the Assistant Director, Forest Protection Force, Billawar laid Nakkas at two locations on Painter-Sukrala Road.

The forest team successfully intercepted a Mahindra Bolero vehicle bearing Registration No. JK08L-3709 at village Tandri on Billawar-Sukrala Road carrying 14 Nos. sleepers of Cedrus deodara (Deodar) having a volume of 40.28 Cft. Accordingly, a case for violation of Section 41 & 42 of the Indian Forest Act, 1927 and the Jammu and Kashmir Forest Produce Transit Rules, 2020 has been registered against the accused and the said vehicle as well as Deodar sleepers have been seized by the forest officials.

The confiscation proceeding with respect to seized timber as well as the criminal proceeding against the accused shall be initiated in the mater.

CRIME REPORT

Absconder nabbed after 5 years
