

Murder case solved, six arrested

JAMMU: Police on Saturday solved a murder case by arresting six accused.

As per details, On June 21. 2023, an information was received at Police Station Khour that a person namely Darshan Lal, son of Lt Gari Ram, resident of Chak Malal Tehsil Khour Distt Jammu was grievously injured and during the treatment succumbed to the injuries. In this regard,



FIR No. 65/2023 under sections 307/147/109/34 IPC and offence under section 302 IPC were registered and investigation started. After this, a team of Police Station Khour led by SDPO Akhnoor Mohan Lal Sharma assisted by SHO Khour Inspr Rahul Mahajan and In-Charge Border Police Post Jogawan PSI Kapil Singh did strenuous efforts and connecting the various leads finally got the information regarding the accused. Finally police teams raided at various places at Kathua, Samba and Reasi Distt. and all the accused persons involved in the gruesome murder of Darshan Lal over land dispute were arrested. Accused involved in the case were identified as Swarn Singh alias Gosha, son of Madan Singh; Sudesh Kumar alias Shinda, son of Madan Lal; Neelam Kumari, wife of Sudesh Kumar; Seema Devi, wife of Swarn Singh; Madan Lal, son of Lt Hansu Ram and Soma Devi wife of Madan Lal all residents of Prangla Tehsil Khour Distt Jammu. The tractor which was used in the commission of the offence was also recovered by the police team.
