The 62-day-long pilgrimage commenced from Kashmir on Saturday on the twin tracks the traditional 48-km Nunwan-Pahalgam route in the Anantnag district and the shorter but steep 14-km-long Baltal route in the Ganderbal district.

"We are very happy to start for Amarnath. I have always longed to see the 'ice lingam' of Lord Shiva," 62-year-old Surinder Joshi from Rajasthan told PTI. Joshi is undertaking the pilgrimage along with his wife Kusum.

A multi-tier security setup has been activated in and around the Bhagwati Nagar base camp for the annual pilgrimage.

Thirty-three accommodation centres have been set up across Jammu and Radio Frequency Identification (RFID) tags are being issued to the pilgrims.

Five counters have been set up for the registration of pilgrims who intend to undertake the yatra. So far, more than 3.5 lakh people have registered themselves online for the pilgrimage.

districts are in Chhattisgarh. I can claim the LWE would have been wiped out of the country had the Congress government fully cooperated," Singh said.

and backward classes as former PM Atal Bihari Vajpayee, he said. Singh also slammed the Baghel government over corruption, claiming, " in five

vears of Congress rule, scams took place in multiple sectors. He mentioned the 'Gauthan' land scam, ration scam, liquor scam and coal scam

in the state, adding that the last one was the Congress's favourite as there was a coal scam when the party was in power at the Centre too.

"Wherever they go, they commit coal scam," he said.

On the elevation of T S Singh Deo as Chhattisgarh deputy Chief Minister, Singh said, "They have appointed a deputy CM for three month. Baghel ji, you will not be save your government by distributing lollipops. The people h vote out the Congress.'

While the Congress-led UPA rule was ridden by scams, no one can level a single allegation of corruption against the Modi government, he said.

"We do not tolerate corruption. If a corruption charge is leveled against any of our ministers, his or her place will be in jail," the Union minister added.

"We fulfilled our promises to scrap Article 370 operating in Jammu and Kashmir and build Ram Mandir in Ayodhya. No other place of worship in the world will be as magnificent as the Ram Mandir being constructed in Ayodhya. People can visit it after January 24 next year," he said.

Singh also hailed Padma Shri recipient Ajay Mandavi, known for teaching wood calligraphy to jail inmates including those arrested in Naxal-related cases in Kanker and encouraging them to return to the mainstream.

At the Baltal base camp too, hundreds of pilgrims lined up at the access control gate early morning where the first batch of around 6,000 pilgrims was flagged off by Deputy Commissioner Ganderbal, Shyambir and other senior officers.

Raman Worlikar, a pilgrim from Mumbai, said he has been performing the vatra for the past many years now. "We wait for Baba's glimpse for a year. We are enthusiastic for the yatra. We pray that the yatra remains incident-free.

The pilgrims -- men, including sadhus, women, old, young and children -- wore their faith on the sleeves as they began the walk to the naturally formed ice-lingam at the cave shrine.

Asked whether they would make any special prayers, the yatris said they will pray that there is prosperity and good health all around "In J-K and across the country."

"We will also pray there is no incident like last year's flash floods and everyone performs the yatra smoothly," said another pilgrim from Mumbai.

A group of yatris from Punjab said they want to thank Baba for everything he has bestowed them with. "I have been coming here continuously since 2009, except for the coronavirus period. This yatra goes on smoothly. Everyone leaves happy from here. Baba listens to everyone. Those who come once, come again," said one of them. Most of the pilgrims were happy with the arrangements made by the Shri Amarnath Shrine Board (SASB) and the J-K administration.

However, some alleged the process to procure registration cards at the base camp were not up to the mark.

The yatra also presents a snapshot of the syncretic culture of Jammu and Kashmir with the local Muslims playing vital role at all points of the pilgrimage "like

Deputy Commissioner Shyambir said the yatra would not be possible without the support of the local people. They provide most of the services including pony rides or 'palkie' rides.

The locals made it to the base camp early in the morning to provide gear like trekking poles made of wood, caps, raincoats etc, to the pilgrims. Many locals have also set up stalls inside the base camp, selling a wide variety of merchandise for the

The Army has said a robust and dynamic security grid complete with the deployment of snipers, anti-drone systems, bomb disposal and dog squads has been put in place to ensure a safe and secure vatra.

The multi-tier security arrangements include domination of the mountains, sanitisation of the yatra route, and round-the-clock domination of the area using the lat-

The army's Special Forces are keeping a watch over the yatra route from vantage locations, the army said.

Apart from the deployment, drone surveillance and RFID chips are also a part of the multi-tier security arrangements for pilgrims. The peaks leading to the holy cave have been covered by the security forces and a round-the-clock vigil is being main-

The yatra this year is the longest-ever, stretching 62 days. It will culminate on August 31 on the occasion of Raksha Bandhan.

In Jammu, officials said security arrangements this year are more elaborate than the previous years. Deputy Inspector General of Police, Jammu-Samba-Kathua range, Shakti Pathak warned of legal action against those involved in duping Amarnath pilgrims by providing fake registration permits.

Over 430 Amarnath pilgrims were found in possession of fake registration permits in Jammu, Kathua and Samba district on Friday.

"Those involved in cheating the pilgrims (by selling fake registration slips) are putting them to unnecessary trouble and grave risk. All such pilgrims were facilitated but an investigation is on to identify the wrong-doers. They will face action," the officer told reporters during his visit to Lakhanpur corridor, the gateway to Jammu and Kashmir, to review yatra arrangements.

"All the requirements of the pilgrims like boarding and lodging have been taken care of. The security is better than before," he said, adding that even the community kitchens were set up inside the four walls for the safety of the pilgrims.

The DIG said the security along the borders and the highway have been tightened and all the concerned security agencies are keeping a close watch.

# HC quashes FIR registered by Crime Branch

JAMMU: The Jammu & Kashmir and Ladakh High Court quashed the FIR No. 9/2018 U/S 409/420/120-B RPC egistered with respondent-Crime Branch.

Justice M A Chowdhary while quashng the FIR, observed that the Crime Branch of Police is only competent to register and investigate those cases which are either by reference made by the government or Director General of Police or regarding the offences contained in the Annexure to SRO 202 dated 03.06.1999.

The contention of the learned Sr. AAG relying upon the Apex Court judgment (supra) that on conclusion of investigation, when offences are proved to have been committed, the natter should be left to be considered by Trial court and the High Court should not quash the proceedings, in the considered opinion of this court is misplaced for the reason that the impugned FIR, entirely on a legal stion without reference to factual ssues, is liable to be quashed. For the foregoing reasons and observations made hereinabove, it is, by now, clear that the case on hand arising out of the FIR No.09/2018 for the commission of offences punishable under sections 409/420/120-B RPC for want of iurisdiction, cannot be investigated by the Crime Branch of Police having egard to the fact that the notification SRO No. 202 dated 03.06.1999, ssued by Government of J&K clearly envisages the offences where Crime Branch of Police is only authorized to egister and investigate and none of the offences are included in the sched-

The petitioner, through the medium of this petition seeks quashment of FIR No.9/2018, registered at Police Station Crime Branch, Jammy on 06.04.2018, for the commission of offences punishable under sections 409/420/120-B RPC allegedly on false/flimsy grounds, being an abuse of process of law.

It has been pleaded that the petitionwas member of the Hindu Education Society, Kashmir (HESK), a registered society which is social and non political body of minority Kashmiri community in the State of Jammu & Kashmir, established to promote and propagate the cause of education, learning, research and raining and also for propagatng/promoting social and cultural activities in the State of J&K and outside in consonance with the ideas of the Hindu Religion and Culture, so that the minority community enjoys the benefits and privileges as enshrined in the Constitution of India. A proposal was mooted by the then president of HESK to purchase around 200 kanals of land in and around Jammu city which was supoorted by U. K. Handoo, member inance and both of them got in touch

promised to them to facilitate the pro-

osed land purchase and in the month

of January 2006, a proposal was circulated amongst members of the Executive Body, however, that at the relevant time, petitioner was not holding any office of HESK and it was only in the month of December 2010, that he was elected as member of the

It was further claimed that a purchase committee was constituted consisting of President, Member Finance and Dr. C N Tickoo as members of the Committee and the process of purchase of land was commenced; that the land was purchased with the help of one Dalip Singh S/O Ram Singh, who acted as a facilitator and a total land of 191 kanals was purchased by HESK from time to time; that realizing that the whole process of purchase of land was being delayed, various meetings were convened for speeding up of the purchase of land and in a meeting of Land Purchase Committee on 11.01.2007, under the chairmanship of Sh. Avtar Krishan Diwani with many members of executive body par ticipating, authorized Sh. U. K. Handoo and Dr. C N Tickoo to expedite the purchase of land and report to the executive body. The land continued to be purchased through registration made by Sh. U. K. Handoo, however, neither physical possession of the land purchased was handed over to HESK, nor any mutation was recorded in the name of this society; that in the month of September 2009, the said Sh. U.K. Handoo resigned from the executive body of HESK from the post of Member Finance and Sh. Avtar Krishan Diwani was authorized to take over the charge of Member

Finance. It is further pleaded in the petition that in the month of December 2010, the elections to the executive body of HESK were held and the new team was constituted having Anil Dhar as president, A.K. Raina as General Secretary and a team of 7 more members including the petitioner herein.

The new executive body, after some investigations, came to know about the hide and seek policy regarding the purchase of land. In an Annual General Meeting (AGM), the executive body was authorized to take any reasonable expenditure to get the process completed with regard to demarcation, mutation and possession of the property/land. It is further pleaded that the term of the petitioner along with other elected members, expired in the year 2014 and, eventually, the petitioner was no more the office bearer of HESK. It was alleged further that to the utter shock and surprise of the petitioner, an FIR was registered against the petitioner and few others at Police Station Crime Branch, Jammu. The petitioner has moved this petition seeking quashment of the FIR, on various grounds, including that no offence is made out on the basis of the evidence, as such, it is an abuse of process of law vith Jagdish Singh, Patwari, who and prayed that the petition be allowed and prayed that the impugned FIR be quashed qua the petitioner.
