

'District Ramban records 6.95% increase in CD ratio'

RAMBAN: Deputy Commissioner, Ramban, Mussarat today directed the Bankers to focus on priority sector and achieve the targets under income generating schemes as he was reviewing the performance of Banks at the District Level Review Committee (DLRC) meeting.

The meeting was informed that banks have expended Rs. 215.68 crore on the priority sector against a target of Rs 566 crore i.e 38% of ACP 2022-23 ending March 2023 and Rs 293 crore under Non-Priority Sector against the target of Rs 65 crore which is 448%.

The Deputy Commissioner directed the LDM and Cluster Head of banks to fix the responsibility of concerned bankers for not achieving the targets under priority sector. He also directed the officers of sponsoring departments to saturate in sponsorship to provide the benefits of different employment oriented schemes to the youth of the district. The Deputy Commissioner emphasized on timely disbursement of loan cases, besides implementing the youth and employment-oriented schemes under differ-

ent segments of priority sector schemes like PMEGP, and CCS for Artisans of Handicraft and Handloom sector; PMWMS, MUMKIN, JK REGP, TEJASWINI, Agriculture, MSME, Housing, and Education in the district.

After detailed deliberations on achievements under different sectors, the DC directed Bankers and Officers of line departments to extend the banking facilities to uncovered areas by using digital modes of banking like ATM service besides sensitizing the people about schemes pertaining to the banking sector.

The meeting was attended by the CPO, Dr. Kasturi Lal, GM DIC Ravinder Anand, Lead District Manager, Abdul Rashid Sofi, Cluster Head JK Bank Parvez Mir, Director RSETI, Vikramjit Singh, DDM NABARD, Arushi Sharma, CHO Anil Gorka, AD Fisheries Fayaz Ahmed, Bankers and various senior officers.

The Deputy Commissioner also took stock of the bank-wise deposits, advances, and the CD Ratio targets. It was informed in the meeting that the CD Ratio registered an increase of 6.95% and stood at 60.35%,

till March 31, 2022.

Asking the Bankers and officers of line departments to come up with a holistic plan for generating job opportunities by promoting local products and tourism activities in the district, the DC said Banks should play a key role to boost the economy of district which is mainly based on agricultural sector by promoting production of agro based products like Honey, Anardana and Quince. Highlighting the importance of IEC activities in implementing various job oriented schemes, the DC advised the LDM and other Departments to prepare a calendar of activity for organizing awareness programmes besides using social media platforms for disseminating information about their schemes, especially pertaining to youth and women folk.

The DC also directed Director RSETI to complete all coddle formalities and start construction work of RSETI building on allotted land at Phalty to provide quality training to youth for facilitating them about job orientation. Director RSETI informed us that a training batch for Tourist Guide will be starting soon at Batote.

Refer this Office notice Letter No. 588-94 dated:- 24-06-2023 and EE/PMGSY/M/615-21 Dated:- 03-07-2023 wherein you were directed to expedite the mobilization of your Sufficient Resources of Men Machinery and Material on the above Road and Bridge Package for their early completion for which you made firm commitments number of Time telephonically that you machineries are on way for the project site but considerable time has elapsed and as also reported by the concerned Assistant Executive Engineer PMGSY Sub Division Inshan no Such Machinery has reached at site as on date which clearly indicates that you are giving false commitments and have therefore fallen foul of your commitments. The contract for the above mentioned works was awarded in your favour by the Worthy chief Engineer PMGSY (JKRRDA) Jammu vide his office allotment No. CEJ/PMGSY/20860-69 Dated:- 26-10-2018 for an amount of Rs. 947.29 lacs as per the agreement entered in with the department vide No. 384/CE/PMGSY/J of 2018-19 Dated:- 26-11-2018. the Stipulated Completion Period of 01 Year and 06 Months had come to its end on 11-05-2020 and even you are not in a position to achieve its first milestone progress. there is further delay of 03 years after elapse fo your Completion period and you are not even serious enough for deployment of your sufficient resources of Men, machinery and maternal at site which us a serious bract of contract on your part. The Progress on part on th said Road & Bridge project is very dismal and sluggish particularly the Bridge work which is being taken very serious by the Principal Secrety to Govt. PW (R&B) Department. The Department has extended all possible support and efforts to expedite the progress of the Project but you have shown no intention to execute the project as per contract agreement. You had remained at persistent and Sustained defaults with intention to Sub-let the whole project which also being in Contravention to laid down norms of SBD claus thereby breaching contract clauses. The DDC/ BDC of the are as well as the other representative are getting very much aggrieved by your prolonged delaying tactics and devolving the general masses of Gunri, Rickenwas and Sukhnai habitation from this basic Road Facility thus Causing huge loss to Govt. exchequer Since the public money is involved.

In the backdrop of the above facts you are notified through the medium of this 3rd and final notice to deploy your sufficient resources of men, machinery and material within 05 days from the issue of this notice failing which the contract will be recommended for termination with imposition of all the liquidated damages and penalty forthwith as warranted under SBD/ Agreement Clause which you should note very carefully and no further communication shall be entertained on your part which you should note very carefully.
