Whereas as per the condition No. 11 of the tender document issued vide e-NIT No. 01 of 2023 dated:- 01-05-2023, the said work was required to be Completed within 30 days which has already been skipped/ elapsed.

Whereas work of this department are time bound and are subject to the onset of rain (Monsoon) for Plantation activities and for which fencing is a prerequisite which has not been completed by you resulting in a situation of non achievement of targets.

Whereas condition No. 18 of the said tender document issued vide e-NIT is reproduced as under:-

You are well aware that the above noted road project has been allotted to you by the Superintending Engineer PMGSY Circle Batote vide allotment No:- PMGSY/SE/B/441-47 dated:- 03-05-2019 with its stipulated Completion period of 21 months but even after elapse of your intended completion period you have failed to complete your allotted work as per th contract agreement entered in the with the department. Due to your consistent Default for not starting the work with sufficient resources of men, machinery and material and arrangement of hot mix plant for black topping of the said Road you were notified through the medium of various notice No. EE/PMGSY/M/335-40 dated:- 23-06-2022, EE/PMGSY/M/386-91 dated:- 04-07-2022, EE/PMGSY/M/833-37 Dated:- 01-08-2022 and EE/PMGSY/M/555-59 dated:- 07-06-2023 last year for deployment of sufficient resources of men material and machinery for early completion of the said road else termination of contract but you approached this office as well as Worthy chief Engineer PMGSY (JKRRDA) Jammu and Superintending Engineer PMGSY Circle Batote not to terminate with the firm commitment made that the work will be completed timely with the deployment of resources required but despite of that you betrayed authorities braching thereby the contract agreement as per laid down clauses. In view of this prevailing situations the Worthy District Development Commissioner Kishtwar (District Magistrate) Served the notice under section 107of Cr.PC (copy enclosed) to appear in person before court of District Magistrate wherein you gave an undertaking and material but even you failed to upkeep your commitments made and thereby defied the same. You are 03 years & 1 months behind your sheduled completion at site which are not sufficient for completion of the work within the month of August as per the target fixed by worthy Principal Secretary to Govt. PW (R&B) Department UT of J&K. The progress at site is extremely dismal and sluggish and it is apparent from your arrangements the work could not be completed as per target fixed and you are only giving false Commitments as the date's committed by you to the authorities have been breached and have fallen foul of your commitments and thus breached the contract agreements inter alia other defaults under the clauses of SBD as you failed to achieved even the first milestone progress after such a prolonged delay thereby causing irreparable loss to the authorities. The Department has extended all Possible Support and efforts to expedite the progress of the said road project but you are showing no intention the excute the project as per commitment made in consonance with target. It is plainly apperent at this stage that you are not serious enough to execute the Road and is causing a huge loss to the Govt. exchequer.

In the back drop of above you are therefore notified through the medium of this 2nd notice to mobilize your sufficient resources of your men, machinery and material at site within 5 days time positively failing which the contract shall be recommended for termination with imposition of all the liquidated damages/ penalties as laid down in the SBD/agreement Clause of teh contract completely at your risk and cost which you should not very carefully. No further communication shall follow henceforth as you have utterly failed to execute the work within the time frame left and are always using delaying tactics.
