**CRIME REPORT**

**4 drug peddlers arrested, contraband recovered**

**STATE TIMES NEWS**  
**SRINAGAR:** Continuing its efforts to eradicate the menace of drugs from the society, police on Monday arrested 04 drug peddlers in Baramulla & Budgam and recovered contraband substances from their possession.

In Baramulla, a party led by SHO Police Station Sheeri under the supervision of DySP Hqrs Shri Altaf Ahmad at a checkpoint established at Gantnulla Balla near Iqbal Resorts intercepted a suspicious person who tried to flee from the spot but was apprehended tactfully.

During search, 26 grams of Charas like substance and 56 SpasmoProxyvon capsules were recovered from his possession. He has been identified as Manzoor Ahmad Yatoo son of Mohd Sultan Yatoo resident of Heewan. He has been arrested and shifted to police station where he remains in custody.

Similarly, officers from Police Station Chandoosa under the supervision of SDPO Kreeri Shri Khalid Ashraf-JKPS arrested one drug smuggler at a checkpoint established near Petrol pump at Kachwa Chandoosa alongwith 145 grams of Charas like substance. He has been identified as Ferooz Ahmad Rather son of Gh Nabi Rather resident of Wagoora. He has been shifted to police station where he remains in custody.

In Budgam, a police party of Police Station Khanshab at a checkpoint established at Drigam intercepted a vehicle bearing registration number JK01F-6877 with two persons on board. During search of the said vehicle, 490 grams of Charas like substance was recovered. They have been identified as Shabir Ahmad Choupan @Shabir Dembali son of Gh Ahmad Choupan resident of Dembal Chadoora and Irshad Ahmad Rather son of Mohd Ayoub Rather resident of Dadompura Chadoora. They have been arrested and shifted to police station where they remain in custody. Vehicle used in the commission of crime have also been seized.

Accordingly, cases under relevant sections of law have been registered at respective police stations and further investigation have been initiated.

**Poonch authorities seize 5 vehicles involved in illegal transportation of minor minerals**

**POONCH:** A coordinated effort of the Police and Mining Department led to seizure of five vehicles involved in the illegal transportation of minor minerals here in the Poonch dis-

trict. The operation was carried out under the direction of Deputy Commissioner, Yasin M. Choudhary and in the presence of District Mining Officer Javid Iqbal.

The joint operation was aimed at curb the illegal transportation of minor minerals and tighten the nose around the perpetrators. Two tippers and one JCB were seized in Behrangala and one dumper and one tipper were seized in Potha by a joint team of the Police and Mining Department.

The vehicles were handed over to the police for safe custody. The DMO Javid Iqbal warned that such illegal activities would not be tolerated and that those found guilty would be punished as per the law. He further urged the public to cooperate with the authorities in their efforts to protect the environment and ensure sustainable development.

**Bike rider dies in road mishap**

**VIJAYPUR:** A Biker was killed after being hit by a truck near Raya morh area of Vijaypur on Monday.

Police sources said that, he has identified as Deepak Pathina, 35 years, son of Mohan Singh resident of Kothe Pathiania. The mishap occurred on Jammu Pathankot National Highway near Raya morh area of Vijaypur in District Samba, when a motorcycle (JK21B-4169) moving towards Bari Brahmana side from Vijaypur, on reaching near Raya morh, suddenly hit by a truck (HR55AF- 8507) resulting bike rider got critical injured and immediately shifted to Government Medical College and Hospital Jammu for treatment where doctors declared him as brought dead.

The body of the deceased was shifted to mortuary room of said hospital for legal formalities. Police have taken cognizance of the matter and started further investigations.

**Bodies of two including woman recovered**
