rom the last four years, Jammu and Kashmir has witnessed a remarkable transformation in its Public Distribution System (PDS). Through series of innovative: reforms and technology-driven initiatives, the government has successfully eliminated leakages, enhanced efficiency, and ensured the benefits of PDS reach the deserving beneficiaries. With over 93% of PDS transactions being conducted online, the beneficiaries now draw their ration through Aadhaar authentication. The authentication system has also made it easier to track the movement of food grains, thus ensuring efficient stock management. By implementing One Nation One Ration Card (ONRC), the government has facilitated seamless portability, enabling beneficiaries to avail their entitled ration from any PDS outlet across the country. This has been of immense help to transient populations and has further strengthened the food security network. The government's meticulous de-duplication exercise led to the deletion of one million ineligible beneficiaries from the PDS system. This exercise not only ensured that the benefits reached the truly deserving ones but also saved substantial resources and reduced the burden on the exchequer. The combined impact of technology integration, Aadhaar authentication, and de-duplication has resulted in substantial financial savings. The streamlined PDS has saved over Rs 230 crores and efficiently distributed 1.6 Lakh MTs of food grains to the needy population. By leveraging technology, embracing Aadhaar authentication, and implementing innovative schemes like ONORC, the administration has set an exemplary precedent for other states to follow. The elimination of leakages. improved efficiency, and significant cost savings are clear indicators of the successful implementation of these reforms. The reformed PDS system stands as a shining example of how good governance can positively impact the lives of the most vulnerable and marginalized sections of society.

In the same way in Hindu religion Lord Shiva a sacred place where all kind of weeds & grasses like hemp, green grass, green leaves of some particular trees are offered with the milk and water consistently, in order to gratify it some people offered it with different kinds of dry fruits, fruits, flowers of different colors and dishes. But it is so astonishing God who is offered with water by the worshippers, whereas any other has not offered with such kind of weeds like hemp and water beverages. In- addition more than two and half months long Yatra has been organized every year throughout the Indian territory towards the Jammu & Kashmir holv cave known as Amar Nath cave, where according to a myth the Lord shiva had delivered with the sermon of



Parvati. And in whose honour and mystics every year there occurred with a snow-fed SHIVLING in a holy cave.

This holy Yatra is adventured in the Jammu & Kashmir where pilgrimages from all over the world used to pay their obeisance. In order to make vatra successful the locals cum others pay their greatest contribution by serving with so many of Langar halls along with the N.H.1, N.H.2, etc likely Chhan -Arorian, Samba, Jammu, Udhampur, Baltal, Chandan-Bari and other parts of northern India. People across the India and world would used to serve the pilgrimages with items like milk, beverages like cold drinks, juice, fruits, dry fruits, food items, blankets, clothes, etc for smooth aviation of the Yatra. The temples along the National Highways are rendered also full of the pilgrimages during these Yatra.

While witnessing one such temple, which is situated at Maheshwar in Samba district, it is said to be resting there since before the regime of Aurangzeb. Whether so proper about its formation none can be assured. But as per myth it is said that when there was not any temple erected of course Shivling was present there. Some animal grazers had noticed that the milkrounding it in the dwellings like Katli, Karandi, and Mandis, etc would have realized so and then deciphered it as holy place in the area.

It also memorizes the very beginning of the ancient Amarnath Yatra when a saint named as Mahant Shambu Giri of Yuna Akhara (Kashi) used to attempt this Yatras every year and while passing by he used to stay here for few days which is presently known as Maheshwar. As per myth once while returning when he reached there during a night suddenly he had left his body for the abode and he was buried here underneath where present SHIVLING is erected. And very soon after of this incidence a temple has been built -up and since then this temple has rendered an epitome of Amar Nath Yatra. During this Yatra so many of the saints of the different Akharas would used to stay there and venerate it

Since then it has renowned in the samba district for its religious sanctity and it invoking in favour of several of its devotees. Its own area is estimated to be more than 12 acres with an elegant corridor. It is flanked by the Villages like Katli, Karandi, Diani, 22 mandis of Samba and

of the pilgrimages including saints from all corners of the India would used to visit the Shivling and invoked with their best fortune for further life. There occurred AMAR NATH YATRA every year in the months of July- August used to be celebrated with great fervor vari-

Though, J&K (UT) administration has made better arrangement for the Yatra there in the J&K (UT). Despite of it there are normal management for the pilgrimages founded in the samba district and lapses of security has been revealed all over yet. Because stone pelting like incidents and seizure of the holy bomb caps from the samba district cause inpanic in the minds of the pilgrimages to opt it or not. Owing to which so many of the pilgrimages had tolerated their plans to visit the holy snow fed-Shivling yet. Despite pilgrimages and common people are thankful to the regime which has made provision of all essential services assured on the one hand and security in all respects including insurance on other hand of every pilgrimage. Though pilgrimages, who are having this Yatra are feeling rejoiced and cheerful than all such prior Yatras as per security and provision of essential service delivery.

Therefore, they arrives from all over the India and world as a holy Yatra in which a snow made SHIVLINGS would used to venerate with milk, honey, Bilpatari, hemp, and different kinds of sweets and beverages like Shatraie, watery- milk, etc. And Bholenath on this occasion blesses to its every devotee with grace and relieves sins & sufferings and bless them with mystic blessings. People comprising of all religions would used to adore it with their best efforts and they offer it with milk, hemp and leaves in worship especially on this occasion. As such 26 opposition parties attended the meeting to set the tone for their 2-2024 Lok Sabha campaign by forming a coalition -Indian National Developmental Inclusive Alliance--to take on the ruling NDA in 2024 polls .The 26 opposition parties have wrapped up their meeting in the seat sharing by the political parties and the common minimum programme as an agenda for fighting the elections well be decided in the coming days .Wrapping the two day meeting with the announcement of a novel name of INDIA to the alliance decided to settle the seat sharing between the political parties at a later date and the PM face will most likely be decided after the elections .Reiteration of the oppositions slogan 'United We Stand' marked the conclusion of the first day of the two day meeting .Ahead of the 2024 general elections leaders of 26 opposition parties discussed major 2024 issues in Taj West End Hotel in the evening as part of their efforts to present a united front against BJP government in the centre.

Today what we discussed ,the outcome will be good for the people of the country .The 26 political parties are the members of INDIA and these include-1- Indian National Congress,2-TMC,3-DMK,4-AAP,5-JDU ,6-RJD,7-JMM,8-NCP Sharad Pawar Group,9-Shiv Sena (UBT) ,10-SP,11-RLD ,12-Apna Dal,13-NC ,14-PDP,15-CPI(M) ,16-CPI,17-CPIML ,18-RSP,19-All India Forward Bloc,20-MDMK ,21-VCK,22-KMDK ,23-MMK,24-IUML,25-kerala congress (M),26-Kerala congress (Joseph).BJP said its alliance is on the basis and idea of India but the opposition alliance is an alliance of corruption and for protecting the dynasties. ### YOUR COLUMN TOLL CHARGES

Toll charges are often the subject of controversy. Earlier it took at least 3-4 minutes in the toll charges payment process for each vehicle. Even non-stop buses were like express buses with at least 5-6 stops for paying toll charges. After the fast tag system was introduced, the vehicle will be almost in motion and the ordeal of stopping at every toll plaza for 3-4 minutes has been buried. A bizarre incident of Karnataka State Road Transport Corporation (KSRTC) bus coming back unable to pay the toll charges in 10-lane road of Bengaluru-Mysuru has been reported. The bus driver had to run the risk of coming back in the one-way road attracting the charges of violating the one-way rule. A suo-motu case has also been registered by the police for violation of rules. The only Expressway between Bengaluru and Mysuru is at the centre of controversy beginning from its inauguration to the toll charges collection work. Instructions have been reportedly issued by the government to private vehicles to

go for fast tag and some concession has also been extended to those who go for fast tag payment. It has been reported that the bus had no fast tag. Unable to pay twice the amount of normal toll charges, the bus had to come back without paying. It is a pity that a state-owned bus could not pay the toll charges. A situation of this kind would not have arisen if the Siddaramaiah government had not given free travel facility to women casting heavy financial burden on the shoulders of KSRTC. When the bus returned without going forward, the time of passengers, cost of diesel and the energy of drivers and conductors were frittered away for no benefit. The benefits obtained from free-travel have been neutralized with the increase in prices of essential goods and services. Had the Congress been wise, it would have reduced the bus fare by 50 per cent to all. The effect of 50 per cent fare to all or 100 per cent exemption to women only is more less the same. After all, men have also voted to Congress. In doing so, it would not have been open to the charge of discrimination on gender basis. Further, it would have discouraged unnecessary journey by the beneficiaries of free travel. The extent of revenue loss also would have dipped.

As bad are too good roads as bad roads. Too good roads are

also prone to accidents due to over speeding like too bad roads leading for mishaps. Good roads are necessary to every nook and corner of the country. Good roads are also necessary to save the precious time. Instead of laving too good national highway roads to reduce the journey time at too high a cost between too big cities inducing the drivers to drive the vehicle at high speed causing many fatal accidents, it is better to make investments in laying good roads to all the places. This would obviate the need for setting up toll plazas in large numbers paving way to concentrate on road development to all the neglected places. Certain minimum standard of quality roads for National and State Highways must be definitely maintained. But roads to the extent of inducing the drivers to drive with high speed and collect toll charges are not necessary. A number of village roads have been neglected and are crying for the attention of the government. The bad roads leading to villages are compounded by infrequent number of buses. It is the duty of a popular government to provide good roads to all the places. In doing so, developments will also take place on
