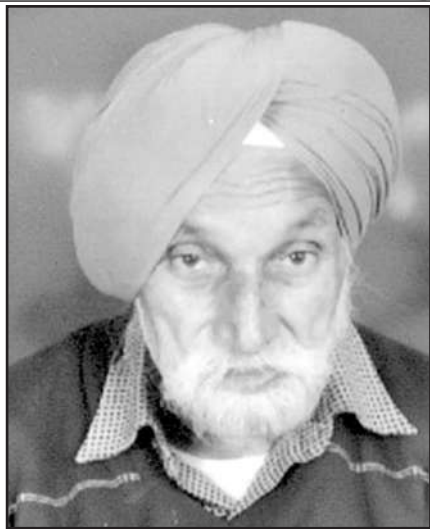
## SHRADHANJALI

## CRIME REPORT

### Drug peddler nabbed with 11.49 grams of heroin

**KATHUA:** Kathua Police continuing its drive against drug menace arrested one person and recovered 11.49 gram Heroin (Chitta) like narcotics from Chhan Morian, Panthal, link road area of Police Station Hiranagar.

A police team led by Insp. Amit Kumar Sangra SHO PS Hiranagar under the supervision of SDPO Border Dheeraj Singh Katoch laid down a routine naka/checking at link road Chhan Morian to Panthal area. During naka checking they apprehended one person namely Anil Kumar Sharma @ Raghu S/o Dhani Ram R/o Chann Moria who is doing the illegal trade of selling narcotics like contraband substance. On Physical search, approximately 11.49 grams of heroin (chitta) like narcotics was recovered/seized from his possession. On this FIR No. 102/2023 U/S 8/21/22 NDPS Act stands registered at P/S Hiranagar and further investigation is under process.

District Police Kathua seeks support from the local people of the area to share information about drug peddling at the concerned Police Station and we are assured that your identity will be kept confidential.

### Absconder arrested after 06 years

**KATHUA:** District Police Kathua under the overall supervi-

sion of SSP Kathua Shivdeep Singh Jamwal has started a special drive to arrest long pending absconders.

SHO Police Station Rajbagh has arrested an absconder named Mohd Tariq S/O Abdul Karim R/o Gool District Ramban. The Accused was absconding for almost 6 years and was evading arrest. Two warrants under Section 512 Cr PC had been issued by the court of law in the case of FIR No. 65/2011 U/S 188/IPC, 3-PCA Act of P/S Rajbagh and FIR No.25/2010 U/S 188 RPC 3 PC Act. A team of Police Station Rajbagh headed by Insp. Tariq Ahmed SHO P/S Rajbagh under the guidance of SDPO Border Dheeraj Singh Katoch JKPS has made the arrest and later produced the absconder in the court of Id. JMJC Hiranagar.

### Police nabs 3, seizes 3 vehicle for illegal mining

**BARAMULLA:** Acting tough against the persons involved in illegal extraction and transportation of minerals, police have seized 3 vehicles and arrested 3 persons in Baramulla.

A police party led by Incharge PP Palhallan under the supervision of SDPO Pattan Shir Mohammad Nawaz seized 3 vehicles (tractors) and arrested 3 drivers for illegal extraction and transportation of minerals at Dargam Nallah Palhallan. The accused have been identified as Asif Ahmad Ganie son of Ghulam Nabi resident of Saloosa Kreeri, Tanveer Ahmad War son of Sonaulah War resident of Tengpora Pattan and Farooq Ahmad Tantray son of Ghulam Qadir resident of Gulabwari Naidkhai.

The police have registered the case under relevant sections of law in Police Station Pattan and investigation set into motion.

## Police arrests 2 eve-teasers

**BARAMULLA:** Police in Baramulla have arrested 02 eve-teasers for harassing a girl at Zanana Park Khawajabagh.

Police Station Baramulla received a written complaint from one person (name withheld) stating therein that two persons namely Aqib Salam Bhat @Ponty son of Abdul Salam Bhat and Yasir Ahmad Bhat son of Fayaz Ahmad Bhat both residents of Fatehpura Baramulla harassed/molested one girl (name withheld) at Zanana Park Khawajabagh and fled from the spot after committing the crime. In this regard, a case under relevant sections of law was registered in Police Station Baramulla and investigation was initiated.

On receipt of this information, a police party led by SHO PS Baramulla under the supervision of Dy SP Hqrs Baramulla Altaf Ahmad-JKPS raided at the various suspected spots. After the strenuous efforts, both the involved persons were arrested for further investigation.

### Police arrests drug smuggler with 105 g Charas

**BARAMULLA:** Continuing its efforts to eradicate the menace of drugs from the society, police have arrested a drug smuggler in Baramulla and recovered contraband substance from his possession. A Police party led by SHO Police Station Kunzer under the supervision of SDPO Tangmarg Intiaz Ahmed-JKPS at a checkpoint established at Pinjoora Crossing intercepted a vehicle bearing registration number DL8CAW-6316 driven by one person identified as Rouf Ahmad Wani son of Nazir Ahmad Wani resident of Roshanabad Pinjoora. During checking, the officers were able to recover 105 grams of Charas like substance from his possession. He has been arrested and shifted to police station where he remains in custody. Vehicle used in the commission of crime has also been seized. Accordingly, a case under relevant sections of law has been registered in police station Kunzer and further investigation has been initiated.
