Udhampur Admn issues notice to FCS&CA Storekeeper Latti for recovery of Rs 31.53 lakh Arrears of Land Revenue

UDHAMPUR: On the directions of District Magistrate, Udhampur; Tehsildar Latti has initiated the recovery proceedings against Maqbool Hussain, the then Storekeeper, Latti, presently attached in Directorate FCS&CA Jammu, to recover the shortages of more than 2732 Qtls food grain amounting to Rs. 31,53,403.18 by issuing writ of demand for recovery as the arrears of Land Revenue.

The said Storekeeper had committed shortages to the tune of more than 2732 Qtls food grain at Food-Store, Latti during his tenure as Storekeeper.

The shortage has been pointed out by a Committee constituted by AD, FSCSA Udhampur after conducting physical verification of the Food Store Latti.

The Assistant Director, FCS&CA, Udhampur, issued a number of recovery notices to the said Storekeeper, but he failed to remit the amount of outstanding shortages within the stipulated time period. Afterwards, the AD FCS&CA requested Deputy Commissioner Udhampur to recover the due amount as arrears of Land Revenue vide letter no. AD/FCS&CA/UDH/23-24/518-520 dated 07-07-2023. Taking cognizance of the report, the District Magistrate, Udhampur, has initiated the process of recovery by issuing notice to Maqbool Hussain, the then Storekeeper, Food-Store, Latti.

If the due amount of recovery is not deposited by the defaulter, his property shall be attached and auctioned to recover the due amount.

Health Department conducts Special camps for Nomads in remote areas

DODA: Primary Health Centre Gundna organized a series of health awareness and medical checkup camps in the higher reaches of the Tehsil Gundna to reach out to the nomadic people residing there with no access to the Medicare facilities.

The camps were held as a part of Azadi Ka Amrit Mahotsav and outreach programme, under the supervision of Chief Medical Officer, Dr Ab Hamid Zargar and guidance of the local BMO.

The camp was organized at Hila Dhar, Handpathar Dhar and Yungwan Dhar for the general checkup including NCD and TB screening of the nomadic population living in high altitude meadows.

During the camps, more than 110 nomads, includ-

ing old age, women and children were examined and screened by the health team, who travelled 4-5 hours of long distance by foot to reach the campsite. The patients were also provided free medicines by the health department team.

Meanwhile, the CMO Doda Dr A H Zargar has asked the BMOs to conduct such health camps in different areas on regular intervals to provide healthcare at the doorstep of the nomads. The nomadic community appreciated the health department for the people friendly health initiative.

The health team, headed by Dr Hamid Parray, comprised Sajad Akhtar (HE), Arshad Latief (Lab Tech), Ajaz Ahmed (ISM Phst) and Ghulam Rasool (MTS).
