It was informed that against 736 works under 272 schemes, 733 have been tendered 680 allotted and work on 301 started of which 54 have been completed so far.

She said that the JJM is envisioned to provide safe and adequate drinking water through individual household tap connections to all the households. The DC directed the con-

She also directed the officers to regularly monitor the quality and progress of all allotted works for their time-bound completion.

The DC also directed the concerned officials to expedite the tendering and evaluation processes after administrative approval and technical sanction is granted by the competent authority, besides ensuring the allotment of works before the set deadlines.
