The scope of the search operation has been expanded to encompass large areas in the adjoining districts of Udhampur and Kathua, including Basantgarh, Seoj (a high-altitude area in Udhampur), and the upper reaches of Bani, Daggar, and Kindli

Special forces of the Indian Army's 'Para' unit have been deployed to conduct surgical operations against the terrorists in speeific areas, the officials said.

Ground search teams are being supported by helicopter and UAV surveillance. Additionally, sniffer dogs and metal detectors are being utilized, with a particular focus on dense forest areas in the region.

The officials said that a joint cordon and search operation, involving the Army, police and CRPF, was launched in Machedi,

Badnote, Kindli, and Lohai Malhar areas, with a significant area placed under cordon. The bodies of the five soldiers were airlifted following postmortem examinations conducted at the Sub District Hospital in

Billawar, Jammu and Kashmir.

Additional Deputy Commissioner of Billawar, Vinay Khosla said that the bodies were handed over to the Army and subsequently airlifted.

He further said that out of eight injured soldiers brought to the Billawar hospital, six were shifted to the Pathankot Military Hospital by the Army.

The officials indicated that currently three to four groups of terrorists, mostly foreign terrorists, are active in the region, adding they have observed an increase in the presence of foreign terrorists in the Kathua-Udhampur-Doda belt and the Poonch-

Rajouri-Reasi belt in recent times. Five Army personnel, including a junior commissioned officer, were martyred, and an equal number were injured in the

ambush by heavily armed terrorists in the remote Machedi area on Monday. According to sources, three to four terrorists, mostly foreigners, are believed to have executed the ambush. They appear to be linked to the same group which was involved in Basangarh attack in which Village Defence Guard Mohd Sharief was martyred

The attack mirrored a similar pattern to the Bhimbher Gali-Mendhar terror incident involving an Army truck on April 21, 2023, where five soldiers lost their lives. The terrorists initiated firing on the vehicle's wheels, followed by bursts of gunfire tar-

The sources said that the condition of the road and the slow speed of the truck in the area likely facilitated the attack.

Investigations into the weaponry and ammunition used in the attack are currently ongoing. In June, security forces had observed movement of a group in the upper reaches of Bani, Daggar, and Kindli areas of Kathua district, leading to subsequent search operations.

for the night and will be resumed Wednesday morning to get a clear picture of the situation.

The encounter in Doda comes barely a day after five army personnel, including a junior commissioned officer, were killed and an equal number injured in an ambush by terrorists in Kathua district.

This was the fourth encounter in Doda district since June 12. While three foreign terrorists were killed in a day-long operaion in the Gandoh area of the district on June 26, five army personnel and a special police officer were injured in a fierce gunfight in Chattargalla pass on June 12.

Another policeman was injured when terrorists opened fire on a search party in Gandoh the next day.

SC closes PIL...

State Commission for Women, the state commission for persons with disabilities and the consumer disputes redressal commission are non functional.

A bench comprising Chief Justice D Y Chandrachud and Justice JB Pardiwala on Tuesday took note of the submissions of the solicitor general that the statutory panels are functional and the powers of some of them are now being exercised by central panels owing to the change in the status of the erstwhile state of Jammu and Kashmir.

The law officer said the powers of three commissions out of the seven are being exercised by the central panels and the rest are functional in the union territory.

He also referred to the affidavit of the law, justice and parliamentary affairs department of Jammu and Kashmir in support

of his submissions. "We will close the case," the bench then said.

"It has been submitted that with the passing of the Jammu and Kashmir Reorganisation Bill, now the laws applicable to UTs are made applicable to the union territory of Jammu and Kashmir...moreover, the central government is vested with the power to direct that the central commissions to function as state commissions," the bench said.

It disposed of the PIL, saying that in view of the present position, the plea has become infructuous and no further directions are required to be issued. The petitioner had made the DoPT (Department of Personnel and Training), the National Human Rights Commission and

the Law Commission of India parties to the PIL.

In August 2019, the Centre bifurcated Jammu and Kashmir into two Union territories and abrogated the provisions of Article 370 of the Constitution which accorded special status to the erstwhile state.

The Jammu and Kashmir Reorganisation Bill was introduced in the Rajya Sabha on August 5, 2019 and passed the same

day. The Lok Sabha cleared it the next day.

SRINAGAR: Secretary, Atal Dulloo on Tuesday held a detailed meeting with representatives of various executing agencies like NHAI, NHID-CL, BRO, Beacon and Project SAMPARK to take stock of progress made so far in laying out of vast network of National Highways across the length and breadth of Jammu and Kashmir.

During this meeting, the Chief Secretary impressed upon the concerned executing agencies to improve their performance with regard to showcasing physical progress on ground.

He observed that frequent change in timelines is not good sign and should be corroborated with clear justifications. He maintained that such unilateral change in deadlines should be avoided in future. Dulloo directed the con-

cerned Divisional and District administrations to regularly monitor the pace of work on these important road projects for their timely completion. He also urged them to extend full assistance to the concerned executing agencies by resolving court cases, land disputes

The later phases of this highway including phase-II (Magam-Pandach) phase-III (Lasjan-Pandach via Dalgate) also came under discussion during this meeting.

The progress on the upgradation of Narbal-Baramulla-Urihighway was given by the NHIDCL during the meeting. It was revealed that the work on Sangrama Flyover is 96% complete and would be thrown open by October this year. It was added that the work on Baramulla Bypass (14.2 Kms) and Pattan Bypass (10.9 Kms) would

In addition the status of Khanabal-Pahalgam Road (NH-501), Rafiabad-Trehgam Road, Magam-Surankot Road reviewed. The progress on Bemina, Sanatnagar and Nowgam flyovers was also taken besides other works rehabilitation of Jawahar Tunnel and old Chanapora Bridge was also discussed during the meet-
