down!" as Secret Service agents piled on top of Trump to shield him. The shooting created chaos with people in the back of the venue immediately run-

As blood gushed from his ear, Trump was then rushed off stage. He boldly pumped his fist into the air and told the crowd to "fight!" He was then whisked away in a car to a Pittsburgh-area hospital.

"Let me get my shoes," Trump said as he was escorted to the safe place.

The shooting, which left one spectator dead and two others critically injured is being investigated as an attempted assassination. The male attacker was also shot and killed by a member of the Secret Service.

A spokesperson for the Trump Campaign said the former president is "fine after the "heinous act."

The gunman was identified by the FBI as 20-year-old Thomas Matthew Crooks of Bethel Park. He was registered to vote as a Republican. In a post on his Truth Social media account, Trump elaborated on what hap

"It is incredible that such an act can take place in our Country. Nothing is

known at this time about the shooter, who is now dead. I was shot with a bullet that pierced the upper part of my right ear. I knew immediately that some thing was wrong in that I heard a whizzing sound, shots, and immediately felt the bullet ripping through the skin. Much bleeding took place, so I realised then what was happening. GOD BLESS AMERICA!" Trump wrote.

The incident happened two days before the start of the Republican National Convention in Milwaukee, where Trump will formally become the party's nominee for the November 5 presidential election.

In a news conference, Kevin Rojek, FBI special agent in charge of the Pittsburgh office, said it was "surprising" the gunman was able to fire multi-

"This evening, we had what we're calling an assassination attempt against our former President Donald Trump," said Rojek.

"We're still working through the security apparatus that the Secret Service had in place, what potentially happened," he added.

"There's going to be a long investigation into exactly what took place and how the individual was able to get access to the location, what type of weapon he had. All that is really days, weeks, and months of investigation."

Bomb-clearing assets were deployed at the scene of the shooting out of ar "abundance of caution," said the FBI.

"It's primarily standard procedure of any suspicious packages, In this case there was identification of a suspicious package around where the shooter was and so we deployed, in an abundance of caution, bomb assets to make sure those were cleared for investigators to move safely in the area, "said Rojek.

Rojek said the crime scene is still active. When asked whether authorities knew what kind of gun was used or how many shots were fired, George Bivens of the Pennsylvania State Police followed up by saying that officials had "a good idea of what the weapon was" but that it was still part of the investigation.

Bivens said that they plan to release information on what caused delays in identifying the shooter. Rojek added that the FBI has not yet identified the shooter's motive

Authorities said they believe there is no other threat.

The FBI has deployed investigative agents, evidence response teams, and other personnel from across the country.

The suspect fired from between 200ft and 300ft away on an elevated shed with an AR-style rifle, multiple law enforcement officers told CBS News.

UG candidates between July 15 and 19 if any grievance raised by students about the conduct of the exam is found to be correct.

While the agency notified the retest schedule on Sunday, it remained silent on the declaration of the result which has already been delayed by over two weeks with the final answer key not yet notified.

The delay in CUET-UG results comes amid a raging row over alleged irregularities in competitive exams, including NEET and NET.

According to NTA sources, the distribution of question papers in language not opted by the candidates is one of the reasons for the retest and the 1000odd candidates are spread across six states.

"Some of the grievances include time loss due to distribution of wrong ques tion paper," a source said.

A total of 250 candidates of the 1,000 CUET-UG aspirants for whom the NTA is conducting the retest are from Oasis Public School in Hazaribagh which is also under scanner for the alleged leak of NEET-UG question paper. According to the official notification issued on Sunday, the grievances received from candidates up to June 30, 2024, regarding the CUET (UG) 2024 exam as well as the complaints sent to rescuetug@nta.ac.in between July 7-9 (before 05:00 P.M.) have been reviewed.

"Based on these grievances, a re-examination will be conducted for those affected candidates on July 19, 2024, in the Computer-Based Test (CBT) mode." the notification said.

Distribution of the wrong question paper also happened during the NEET-UG exam conducted on May 5, due to which NTA granted grace marks due to However, the agency, following protests and litigation in the Supreme Court

cancelled the grace marks and announced an optional retest for the 1,563 can didates of which 813 attended the exam on June 23. Originally, results for the undergraduate admission test were scheduled to be

released on June 30 but the NTA delayed the results as it grappled with paper leak allegations involving NEET-UG, UGC-NET, and CSIR-UGC-NET. "Initially it was decided that the results would be announced for the rest of the candidates before the retest and subsequently for the rest. However, we are

now yet to take a final call on the same," a source said. The CUET-UG exam conducted in a hybrid mode for the first time across the country was cancelled in Delhi a night before the scheduled exam day, cit-

ing logistical reasons. The exam was conducted in the national capital later. The NTA had earlier announced that the third edition of CUET-UG will be completed in seven days and there will be no normalisation of scores as all exams will be conducted in a single shift.

# Teenager hangs self in Rajouri, relatives stage protest

RAJOURI/JAMMU: A 17-year-old boy was found hanging from the ceiling of his house Rajouri district after he was allegedly harassed by some people, police said on Sunday.

The police said that Akshay Kumar's relatives blocked the Jammu-Poonch highway and demanded an inquiry into the circumstances leading to his death. Kumar was found hanging from the ceiling of his room at village Kallar Saturday evening,

police official said. Kumar's family members and other relatives claimed that he was being harassed by some

people after he was recently seen with a girl at a restaurant, police said. They claimed that the boy ended his life under pressure from these persons and demanded

in inquiry into the matter, police said.

However, they later dispersed on the assurance of police and civil officers that an investiga tion had begun into the case, police added.

## Akhnoor youth ends life by jumping in Chenab, body found in Pak

JAMMU: The body of a youth who ended his life allegedly by jumping into the Chenab river here last month was recovered in Pakistan, following which his family sought Prime Minister Narendra Modi's intervention to bring back the mortal remains for last rites.

Harash Nagotra, a resident of a border village in the Akhnoor sector, went missing on June 11 and his motorcycle was recovered on the banks of the river.

A police official said a missing report was registered by Nagotra's family the next day. Preliminary investigation suggested that he might have ended his life by jumping into the

river after suffering a loss of over Rs 80,000 in an online gaming application, the official said The family got the confirmation about Nagotra's death through a WhatsApp message from a Pakistani official after the parents reactivated a SIM card of their son who worked in a private telecommunication company. Nagotra's father Subash Sharma said the WhatsApp message from the Pakistani official, who claimed to be posted in the post-mortem department informed them that the body was recovered from a canal in Sialkot in Punjab province on June 13. The official had informed the deceased's father that the body had been buried. He also sent Nagorta's identity card to the grieving family through WhatsApp, confirming that the body recovered in Sialkot is that of their missing son.

"We request our Prime Minister to help us get back the body of my son for last rites. We want to perform his last rites as per our religion," Sharma said. Nagotra's relative Amrit Bhushan said they have already written to the External Affairs Ministry, Home Ministry and the Prime Minister's Office over the matter. "We are in a state of shock and grief and want his body back We have also appealed to Pakistani authorities to hand over the body," Bhushan added.
