JAMMU: Kavinder Gupta, senior BJP leader and former deputy Chief Minister today expressed unwavering confidence in the capability and dedication of security forces dealing with terrorism.

In a press release issued to media persons, the senior BJP leader emphasized on the importance of solidarity and support for the brave men combating terrorism from the front.
