VK Chaurasia, Advisor and Satish Kumar, Assistant Advisor, Central Public Health and Environmental Engineering Organisation (CPHEEO) and other experts from the National PMU, Ministry of Housing & Urban Affairs (MoHUA) GoI made detailed presentations on Toilet coverage in ULBs, implementation gaps, preparation of DPRs for Used Water Management and declaration of towns as Safaimitra Surakshit Shehar.

The experts shared their insights with the participants and there were healthy discussions during the workshop on different aspects of Used Water Management. Besides, guidance was provided on progressing of ULBs towards ODF+ and ODF++ certification in the forthcoming third party assessment to be conducted by Ministry of

Housing & Urban Affairs, GoI. The experts also advised the ULBs to ensure that all community and public toilets in all urban areas are functional, clean, and inspected at least once a week. They also laid emphasis on renovating & revamping of existing Community and Public Toilets, besides moving further towards construction of more Community and Public toilets especially Aspirational Toilets.

The workshop covered various techniques for treating wastewater through Sewage Treatment Plants (STP) and Effluent Treatment Plants (ETP), as per the population categories of Urban Local Bodies. It also highlighted the Safai Mitra Surakshit Shehar Protocol, focusing on the safety of sanitation workers involved in cleaning septic tanks or sewers, besides using modern equipment for safe desludging operations and desilting of drains.

Mandeep Kaur conducted detailed deliberation on the presentations made during the workshop. She asked all stakeholders to prepare comprehensive Detailed Project Reports (DPRs) incorporating advanced technologies, including nature-based solutions for used water treat-

The affidavit said for 2024-25, the counselling process for undergraduate seats will be conducted in four rounds starting from the third week of July.

The NTA has also filed a separate additional affidavit on the similar lines and said it has carried out an analysis of distribution of marks at the national, state and city

"This analysis indicates that the distribution of marks is quite normal and there seems to be no extraneous factor, which would influence the distribution of marks," the NTA said in its affidavit, which also gave details of the system in place for ensuring confidential printing of question papers, their transportation and distribution.

While hearing the pleas on July 8, the top court had observed that the sanctity of the NEET-UG 2024 has been "breached".

Saying that a re-test may be ordered if the entire process was affected, the bench had sought details from the NTA and the CBI, including the timing and manner of the alleged paper leak, besides the number of wrongdoers to understand the extent of irregularities claimed by the petitioners.

More than 23.33 lakh students had taken the test on May 5 at 4,750 centres in 571 cities, including in 14



Cong to launch stir against terror activities

JAMMU: The Jammu and Kashmir Congress will on Friday launch an agitation against the alleged failure of the BJP-led government to check growing terror activities and its decision to give unbridled powers to the Lt Governor ahead of the assembly polls in the Union

Jammu and Kashmir Congress chief Vikar Rasool Wani on Wednesday said, "The agitation will start at the state level and be taken to the district and block levels in the coming days.

"We will also press for the restoration of statehood before the Supreme Court's September 30 deadline for the holding of Assembly elections," Wani told reporters here. Criticising the BJP for "destroving the historic state" over the last 10 years of its rule at the Centre, Wani said Jammu was cleared of militancy during the Congress-led UPA government but the BJP has completely failed to provide security to the people who are gripped by fear due to the revival of terrorism. "When they (BJP) were out of power before 2014, they were asking Congress that you have an army, paramilitary and police and why you are not able to wipe out terrorism. Today, I am asking the same question as terrorism is back in Jammu region," he said.

While campaigning for the Lok Sabha polls that concluded recently, the BJP nade tall claims about ending terrorism
