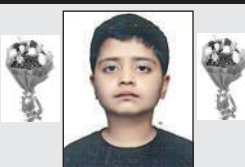

Whereas, the Board vide Notification No. 045-BOPEE of 2024 dated 11-07-2024, had notified the Provisional Merit List for NEET MDS Courses -2024 for inviting objections, from the candidates figuring in the said merit list up to 13-07-2023 till 02.00 p.m.

Whereas, the Board has received one representation from the candidate namely Dr. Danish Hamid under JKPM category which was thoroughly examined by the Board and accordingly his claim is rejected under rule as the seats shall be allotted strictly as per the new reservation policy vide S.O 176 dated 15-03-2024 from the current session onwards.

Whereas, one of the candidates bearing roll no. 2455105380 figuring at s.no. 41 of the Provisional Merit List failed to submit all the documents up to the prescribed date i.e., 13-07-2024 and hence the Board has decided not to allow her to participate in the counselling process and therefore her candidature is rejected.
