 The following procedure shall be adopted during the conduct of Mop-up round of Counselling (Physical):

- The Candidates applied under B-Pharmacy (Lateral Entry) Course-2024 are also eligible for this round of counselling and shall have to report BOPEE Offices Jammu/Srinagar on 23-07-2024.

- Those Candidates who remained absent or have opted CNA/SNA during 1st or 2nd round of Counselling shall be eligible to participate in this Mop-up Round of Counselling.
