may remain vacant and the Board may decide to fill the same from Open Merit category candidates.

- It shall be the sole responsibility of the College/Institutions concerned to ensure proper check and verification of documents/eligibility as per guidelines issued by DCI before the candidate is allowed for admission and in case of any discrepancy in the requisite documents, same is required to be reported to the Board for taking further course of action under rules.
- In order to complete the admission process within the prescribed Cut-off date the Colleges/Institutions shall keep their admission counters open even on Holidays/Off days/Sundays, if any, falling in between to facilitate the candidates to complete their admission process well in time. However, the candidates should in their own interest avoid waiting for the last day to complete admission formalities since delay has the potential of causing hardships to the candidates only.

The Heads of concerned Colleges/Institutions shall furnish the shortfall of the seats, if any, to the Board on 25.07.2024 till 05:00 p.m. through the E-mail and hard copy duly signed by the Head of the Institution on 26.07.2024 by 11:00 a.m. positively.
