Whereas, as per the Indent/Advertisement Notification, the prescribed qualification for the post(s) is/was "Matric with Science Subject"; and

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid posts among other posts of Animal/Sheep Husbandry and Fisheries Department vide Advertisement Notification No. 04 of 2021 dated 17.07.2021 and vide Advertisement Notification No. 04 of 2022 dated 27.07.2022, respectively and the cut-off date, i.e., the last date for applying for the aforementioned posts and for determining the eligibility/academic qualification and validity of category certificates and other such documents of the candidates which may be required as per indent was 17.09.2021 and 20.09.2022, respectively for the above mentioned two notifications. and

Whereas, the Jammu & Kashmir Services Selection Board (JKSSB) conducted written examination for the post of Stock Assistant, Animal/Sheep Husbandry& Fisheries Department on14.01.2024; and

Whereas, the JKSSB, vide Notification No. JKSSB-COE0EXAM(UT)/103/2023-03 (7368109) dated 01.02.2024, issued the result/Score Sheet of the candidates who appeared in the OMR Based Written Examination held on 14.01.2024, for the said post. Thereafter, schedule for Documents Verification (D.V.) of the Candidates falling under the consideration zone was notified vide Notification No. JKSSB-COEOEXAM(UT)/103/2023-03(7368109) dated 12.03.2024 and Supplementary Document Verification (D.V.) vide No. JKSSB-COEOEXAM(UT)/103/2023-03(7368109) dated 20.03.2024; and

Whereas, the Selection Committee for preparing the selection to the aforementioned posts was constituted vide Order No.187-SSB of 2024 dated 14.05.2024; and

Whereas, the Hon'ble Central Administrative Tribunal, Jammu Bench, while vacating the stay in Original Application No. 61/1239/2021, titled Deepak Kumar and Ors. Vs UT of J&K and Ors., in its order dated 29.05.2024, directed that:

> "... 15. The case of the applicants is that they are better suited candidates for selection to the post of Stock Assistant and Assistant Stock Man in the Animal Sheep Husbandry Department, as they possess one year diploma in Paravet Training Course and Stock Assistant Training Course from Government institutions, in comparison to candidates possessing qualification of matric with science, prescribed in Advertisement Notification No. 04 of 2021 dated 17.07.2021. The applicants seek weightage and preferential marks for possessing diploma. In our considered opinion, weightage or preferential marks can only be granted, if the same has been prescribed in the advertisement or recruitment rules. In the case in hand, from perusal of record, we find that the prescribed qualification for the post of Stock Assistant and Veterinary Pharmacist is matric with science only and there is no provision for granting weightage or preferential marks for possessing diploma in the subject concerned.

> 16. Since, there is no such provision in the advertisement notice or recruitment rules granting weightage or preferential marks for possessing diploma in the subject concerned, the applicants cannot demand weightage or preferential marks. The applicants are basically trying to prescribe qualification for post of Stock Assistant and Veterinary Pharmacist, which is the sole domain of the employer only.

> 17. In this regard reliance is placed on the judgement of Hon'ble Supreme Court in the case of Maharashtra Public Service Commission Vs. Sandeep Sharma and others (2019) 6 SCC 362, in which it was held as under:

"9. The essential qualifications for appointment to a post are for the employer to decide. The employer may prescribe additional or desirable qualifications, including any grant of preference. It is the employer who is best suited to decide the requirements a candidate must possess according the needs of the employer and the nature of work. The court cannot lay down the conditions of eligibility, much less can it dwelve into the issue with regard to desirable qualifications being on a par with the essential eligibility by an interpretive re-writing of the advertisement. Questions of equivalence will also fall outside the domain of judicial review. If the language of the advertisement and the rules are clear, the court cannot sit in judgement over the same. If there is an ambiguity in

the advertisement or it is contrary to any rules or law, the matter has to go back to the appointing authority after appropriate orders, to proceed in accordance with law. In no case can the court, in the garb of judicial review, sit in the chair of the appointing authority to decide what is best for the employer and interpret the conditions of the advertisement contrary to the plain language of the same."

18. It also appears from the record that many of the applicants had participated in the selection process for the post of Stock Assistant and Veterinary Pharmacist, however, they could not succeed in the same and, thereafter, they have challenged the selection process. It is also a settled law an unsuccessful participant cannot turn around and challenge the selection process, after participating in it without any challenge.

19. In the case of Tajvir Singh Sodhi and Ors Vs. The State of Jammu and Kashmir and others 2023 LiveLaw (SC) 253, it was held that:

"13.1 It is, therefore, trite that candidates, having taken part in the selection process without any demur or protest, cannot challenge the same after having been declared unsuccessful. The candidates cannot approbate and reprobate at the same time. In other words, simply because the result of the selection process is not palatable to a candidate, he cannot allege that the process of interview was unfair or that there was some lucana in the process. Therefore, we find that the writ petitioners in these cases, could not have questioned before a Court of law, the rationale behind recasting the selection criteria, as they willingly took part in the selection process even after the criteria had been so recast. Their candidature was not withdrawn in light of the amended criteria. A challenge was thrown against the same only after they had been declared unsuccessful in the selection process, at which stage, the challenge ought not have been entertained in light of the principle of waiver and acquiescence."

20. In view of the aforesaid judicial pronouncements and discussions made herein above, the O.A. being devoid of any merit is dismissed.

21. The interim order dated 17.08.2021 passed by this Tribunal restraining the respondents from declaring the result of the selection stands vacated. The respondents are at liberty to declare the result and take further action, as per rules.

22. No order as to costs."

Whereas, upon directions from the Hon'ble Central Administrative Tribunal, Jammu Bench stated above, the provisional selection list for the aforementioned posts, prepared as per the merit/eligibility of the candidates and having regard to the extant rules /regulations was approved bythe Board in its 276th Meeting held on 25.06.2024 and subsequently notified vide Notification No.JKSSB-Scry/14/2024-03(E-7508166) dated 27.06.2024, seeking objections from the candidates;

Whereas, pursuant to the above, various representations were received in the Board, pertaining broadly to submission of documents w.r.t. withheld cases, correction in particulars etc., which were examined as per the available record/extant guidelines; and

Whereas, the proposal for notifying the Final Selection List for the aforesaid posts of Stock Assistant, Animal/Sheep Husbandry and Fisheries Department, advertised vide Advertisement Notification No. 04 of 2021 dated 17.07.2021 and 04 of 2022 dated 27.07.2022, respectively, as prepared by the concerned Selection Committee, was placed in the Board in its 279th meeting held on 25.07.2024, which after due consideration and deliberation on various aspects attendant to the selection, approved its notification.

Now, therefore, the Final Selection List of the candidates for the posts of Provisional Selection List for the aforementioned posts of Stock Assistant, Animal/Sheep Husbandry and Fisheries Department, advertised vide Advertisement Notification No. 04 of 2021 dated 17.07.2021 and 04 of 2022 dated 27.07.2022, respectively, is hereby notified as Annexure-A to this Notification. It is further notified that:

- 1. The above Final Selection List shall be subject to outcome of the OAs/Writ
- Petition(s), if any, pending adjudication before any Competent Court of law. 2. The List shall also be subject to the outcome of such enquiry, involving any
- candidate(s), as figuring in this List. 3. The formal recommendations to the concerned Indenting Department shall be
- forwarded separately. 4. The candidates whose recommendations are kept withheld shall submit the
- requisite documents/certificates within a period of one month. 5. The Selection of the candidates has been made on the basis of Selfdeclaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured
