Whereas, it appears to the Government that a total of 02K-05M land is required at the village Kanthi Tehsil & District Ramban for public purpose, namely for the "Construction of Approach road to ISM Dispensary at Kanthagali in village Kanthi" Tehsil & District Ramban.

Whereas, Director Ayush J&K, Jammu placed an indent vide his No. Dir-Ayush/P&S/68-II/7965-67 dated 29-05-2023 for the acquisition of private land measuring 02KIs-05MIs situated in village Kanthi Tehsil & District Ramban for the "Construction of Approach road to Dispensary at Kanthagali in village Kanthi".

Whereas, Tehsildar Ramban prepared the revenue papers of land measuring 02KIs-5MIs in consultation with the Indenting Department and submitted to this office vide his No. TR/OQ/2023-24/Rev/247 dated: 16.05.2023 and the same were authenticated by the Indenting Department in token of its correctness.

Whereas, the Government of Jammu and Kashmir, Revenue Department Civil Secretariat, notified the final draft rules i.e. "The Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2023 vide S.O 440 dated 24th of August, 2023.

Whereas, the indent placed by the Director Ayush J&K, Jammu was perused in consonance with the provision contained in the aforementioned rules notified vide S.O 440 of 2023 dated 24.08.2023 and it was found that the Indent was placed as per the Rule 3(1), (3) & (5) of The Jammu and Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2023.

Whereas, this Collectorate constituted a committee vide No. Acq/Gen/Rbn/23/441-50 dated 28.12.2023 as per Rule 4 of the Rules notified vide S.O. 440 of 2023 to conduct preliminary enquiry in the said land acquisition case.

Whereas, the committee submitted its report duly endorsed by Tehsildar Ramban vide his No.TR/OQ/2024-25/Rev/454 dated 18.07.2024 perusal of which reveals that there is no State/Common land available which would serve the public purpose and the only option is to acquire the propose patch of land. Further, there is no involuntary displacement involved in the acquisition of said land and accordingly, no rehabilitation is required. No fruit bearing/Non-fruit bearing trees are available on the spot. The whole road alignment falls

outside the demarcated forest are. Land owners have no objection on the said acquisition and consent as required under Sub-rule (2) of Rule 17 and Sub-rule (1) of Rule 20 on Form-V (Part-A) (Prior Written Consent of the Affected Land Owners or Declaration Form) has been obtained from them. Resolution of Gram Sabha as per Sub-rule (7) of Rule 21 on Form-V (Part B) has also been obtained. Hence, the committee recommended that this report be considered as Social Impact Assessment (SIA) Report which is mandated under section 4,5,6,7 & 8 of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and Rule 9, 13,14,15,16 and 17 of Jammu & Kashmir Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules 2023".
