During the training, the DSEO highlighted that reporting of Birth and Death events on the newly revamped Civil Registration System (CRS) Portal is mandatory within 21 days for all Government and Private Hospitals. Additionally, the process of manually seeking files has been dispensed with, streamlining the entire registration procedure in online mode.
