KATHUA: Five army personnel including a Junior Commissioned Officer (JCO), were martyred and as many were injured on Monday when heavily armed terrorists ambushed a patrolling party on the Machedi-Kindli-Malhar road in district

The terror attack, the fifth in Jammu region in a month, evoked widespread condemnation with political leaders including three former chief ministers expressing concern over the growing terror incidents, especially in the Jammu region where militancy has returned after being wiped out over two decades ago.

The terrorists targeted an army truck, part of a routine patrolling party, with a grenade and gunfire on the Machedi-Kindli-Malhar road near Badnota village in Lohai Malhar, approximately 150 km from Kathua town, at around 3:30 pm, the officials

After the ambush, the terrorists fled into the nearby forest, as the army, assisted by police and paramilitary personnel, retaliated.

The army vehicle, carrying ten



occupants, bore the brunt of the attack, resulting in fatal injuries to five soldiers, including a JCO. Five others have been shifted to Pathankot military hospital for treatment.

An exchange of fire between the terrorists and security forces ensued, with reinforcements quickly dispatched to the area to neutralise the attackers - believed to be three in number and heavily armed - who may have recently infiltrated from across the border.

Kashmir Tigers, a shadow outfit of the banned Pakistan-based Jaish-e-Mohammad (JeM), has claimed responsibility for the attack.

It is the second major terror incident in Kathua district within one month, following a similar confrontation on June 12 and 13 that left two terrorists and a CRPF jawan dead.

A massive search operation is on despite heavy rains, the officials said.

Director General of Police R R Swain is personally overseeing the anti-terrorist operation in the dense forest area, connected to Basantgarh in Udhampur district, where several encounters have occurred in the past.

The forest area is connected to Basantgarh in Udhampur district. A village defence guard Mohd Sharief was killed in an encounter with terrorists on April 28 in Panara village of Basantgarh.

The officials said there were apprehensions that this route was used by terrorists to reach the hinterland after they managed to sneak in from

The Jammu region, known for its peaceful atmosphere, has been shaken in recent months by a series of ambushes and attacks by terrorists, particularly in the border districts of Poonch, Rajouri, Doda, and Reasi.

The recent escalation in terrorist activities has been attributed to attempts by Pakistani handlers to reignite terrorism.



JAMMII. District Magistrate Sachin Kumar Vaishya has initiated the process of declaring wanted land grabbers Abdul Majid alias Bittu Teli, and Talib Hussain as absconders in view of their prolonged absence. Prior to this, the Public Safety Act (PSA) had been invoked against the duo.

The PSA was invoked as a consequence of their involvement in unlawful land conversion activities, specifically the conversion of forest land into regular parcels and the subsequent sale of these parcels to unsuspecting buyers.

As their activities posed a potential threat to public order, the PSA was slapped against Abdul Majid and Talib Hussain, Given their current absence, the district administration has taken the proactive step of declaring them absconders and will simultaneously initiate the process of attaching their properties.

India seeks to play a "supportive role" for a peaceful and stable region, the prime minister said in his departure

Modi was received at the Vnukovo-II



airport by Russia's First Deputy Prime Minister Denis Manturov. The Russian first deputy minister also accompanied the Indian prime minister to his hotel from the airport, officials said.

Manturov had received Chinese President Xi Jinping during his visit to Russia as well.

On Tuesday, Modi will co-chair the 22nd India-Russia annual summit with President Putin, interact with the members of the Indian community and visit the Rosatom pavilion at an exhibition.

The prime minister is also scheduled to lay a wreath at the 'Tomb of the Unknown Soldier'.

# Police officials afraid of anti-national, anti-social elements, don't deserve to be in belt force: HC

JAMMU: Justice Sanjay Dhar of Jammu & Kashmir and Ladakh High Court on Monday observed that if officers and officials of the police force, who are assigned the task of protecting the life and property of the common people, feel afraid of antinational and anti-social elements, then they do not deserve to be the part of the belt force.

While hearing a petition, the court observed that if the guardians of security of the common people abdicate their duties, then only God can save this Country.

The order has been passed in a petition filed by Aijaz Rashid Khandey, who challenged order No.125 of 2019 dated March 27, 2019, whereby his services as Special Police Officer (SPO) have been disengaged on account of his unauthorised absence from duty with effect from October 3,

It is case of the petitioner that he was engaged as an SPO in the year 2014 in terms of order No.355/2014 dated July 8, 2014 issued by respondent No.4. The petitioner was allotted belt No.526/GRP-K and in terms of order dated August 19, 2014, he was posted at GPRS, Anantnag. According to the petitioner, he performed his duties to the satisfaction of his superiors

It has been submitted that in 2016, law and order situation in Kashmir Valley, particularly in South Kashmir, became precarious and the police personnel, particularly the SPOs started receiving threats to their life from terrorists and they were asked to give up their jobs. Even otherwise, such an enquiry was not necessary at all in the facts and circumstances of the present case because, admittedly, the petitioner was absent from duty from October 3, 2018 upto February 19, 2019 when he approached the respondents for resuming his duties. The explanation tendered by the petitioner for not attending his duties is that he was threatened by terrorists and was asked to give up his duties. The explanation given by the petitioner for his unauthorized absence from duty is not tenable at all. If officers/officials of the police force, who are assigned the task of **■ CONTD ON PAGE 9**
