Sub: - Traffic Management Plan in Jammu City for Shri Amarnath Ji Yatra-2025.

Shri Amarnath Ji Yatra-2025 (SANJY-2025) shall commence w.e.f. 3rd July 2025 and will conclude on 9th August 2025. The first Convoy shall move from Yatri Niwas Bhagwati Nagar Jammu on 2nd of July 2025. The departure timings for both the Convoys are 0400 hours for Baltal Convoy and 0430 hours for Pahalgam Convoy. Keeping in view the highly increased volume of traffic during the Yatra

period, the following restrictions/ diversions shall be put in place in Jammu City. * No traffic movement shall be allowed on the following routes during

Convoys' movement: -

1. Canal Head towards Shri Banda Bahadur Chowk.

2. R&B Bridge Belicharana towards 4th Tawi Bridge.

3. Fly-over take-off point (in-front of GCW Gandhi Nagar) towards Asia Crossing as well as Bikram Chowk (via Fly over).

4. Panama Chowk towards Hotel Asia via Directorate of Fire & Emergency

5. PHQ towards Bikram Chowk via Jammu University.

6. Ware House towards Bikram Chowk.

7. B.C Road from Bus stand to Manda including the following laterals:-

a. Indira Chowk to K.C Crossing.

b. Maheshpora Chowk to Shakuntala Crossing.

c. Vigilance Rotary to Shakuntala Crossing.

d. Sarwal/ Subash nagar lanes towards Rehari Chowk.

e. Exchange Road towards Rehari Chowk.

f. Amphalla Jail Road towards Amphalla Chowk.

g. Janipur road towards Ved Mandir/ Ambphalla Chowk. . Cut off points shall be established at following locations during the Yatra

period: -

1. Kunjwani Chowk.

2. Bajalta Cut.

3. Sidhra Cut.

4. Atal Chowk.

TCP Nagrota.

6. Manda. No HMVs and LMVs shall be allowed beyond these cut-off points after 2200 hours and 2400 hours respectively.

* MAJOR DIVERSIONS: -

1. Both the tubes from JKP Martyrs Memorial Chowk, Railway Station to Railway Crossing, near Divisional Commissioner office shall be closed for any vehicular movement. All such vehicles shall be diverted via Zorawar Singh Chowk and Panama Chowk.

2. No Traffic (except SANJY-2025 Convoy vehicles) shall be allowed from Shri Banda Bahadur Chowk towards Bhagwati Nagar and will be diverted via Canal Head.

* NO PARKING AREAS: -

Canal Head to Yatri Niwas Bhagwati Nagar via Shri Banda Bahadur Chowk.

4th Tawi Bridge to Asia Crossing via Ware House.

K.C Crossing to Manda.

* Kashmir bound vehicles shall be allowed onwards from TCP Nagrota between 0600 hours to 1200 hours. However, this timeline is subject to change as per ground requirement.
