While Arif, in his late 20s, was "tactfully captured", the four terrorists jumped off the cliff when they noticed the Indian Army. They landed in 'No Man's Land' and returned to Pakistani side under the cover of thick foliage and adverse weather conditions, the officials said.

Army troops could not open fire on the terrorists due to the presence of Pakistani posts nearby, they said. Drone footage of the area showed a blood trail, indicating that the terrorists had suffered injuries due to the fall.

Arif was in possession of a mobile phone and some Rs 20,000 in Pakistani curreney and told his interrogators he was aware of the topography of the area as he is a resident of the Line of Control on the Pakistani side and working at the behest of Pakistani army to help the terrorists to infiltrate into the Indian side, the officials

They said the terrorist guide is undergoing detailed interrogation and crucial intelligence is being extracted. This will help in further strengthening the counter-infiltration grid.

# Court rejects bail...

hearing both sides, emphasized the gravity and societal impact of the offence, noting the seizure of an exceptionally large quantity of heroin from the conscious pos-

Quoting the Supreme Court's guidelines, Judge Sharma underlined that for offences under the NDPS Act, particularly those involving commercial quantity, bail can only be granted if the court is satisfied that there are reasonable grounds to believe the accused is not guilty and is unlikely to commit such offences while on pail-conditions that were clearly not met in this case.

"The offence is of a serious nature and directly affects society at large. The drug menace is rising at an alarming rate and is eating into the future of our youth like a termite," the court observed. "Given the magnitude of the crime and the evidence presented, including jail visit records and call data analysis, the petitioner does not deserve the judicial discretion of bail."

The court further held that the rigours of Section 37 of the NDPS Act applied squarely to the case, making the accused ineligible for bail in the absence of a prima facie finding of innocence. Accordingly, the bail application was dismissed as devoid of merit.

For trains departing before 2 pm, the charts will be prepared the previous night at 9 pm, the statement said, adding that the minister has directed the change to be implemented in a phased manner to ensure no disruptions.

This move will reduce uncertainties for passengers with waitlist tickets, it said, adding that the first update on waitlist status will be shared in advance.

"It will benefit passengers travelling from remote locations or suburbs of major cities for catching long-distance trains. It will also provide more time to make alternative arrangements in case the wait list is not confirmed," the ministry said.

"The new upgraded Passenger Reservation System (PRS) will allow over 1.5 lakh ticket bookings per minute. This will be an increase of roughly five times from 32,000 tickets per minute in the current PRS," it added.

The ministry said the new PRS also has a multilingual and user-friendly booking and enquiry interface. In the new PRS, users will be able to submit their choice of seat and see the fare calendar. It also has integrated facilities for Divyangjan, students and patients, officials said.

The ministry further said that only authenticated users would be allowed to book Tatkal tickets on the IRCTC website and mobile app from July 1 onwards.

It emphasised that OTP-based authentication will be done for Tatkal bookings from the end of July.

# Eight narco smugglers nabbed with heroin

POONCH/DODA/SAMBA: In its sustained efforts to curb the menace of drug trafficking and substance abuse, District Police Poonch today achieved a signifi cant breakthrough by apprehending a drug peddler and seizing a heroin-like sub stance from his possession.

At approximately 1700 hours, a routine naka was laid by the alert personnel of Police Post Mankote in the Mankote area. During the checking operation, a sus picious individual approaching on foot from the Mendhar side towards Sagra attempted to flee upon spotting the police. However, the vigilant naka party acted promptly and successfully intercepted him.

Upon personal search, 2.5 grams of a heroin-like substance was recovered from the individual. He has been identified as Sameer Khan, son of Mohd Rashid Khan, resident of Sagra, Mankote.

Following the recovery, a case has been registered under FIR No. 105/2025 under the relevant sections 8/21/22 of the NDPS Act at Police Station Mendhar The accused has been arrested, and further investigation is in progress to ascer tain the source and possible network behind the illegal trade.

### 4 drug peddlers held with contraband substances worth Rs 7 lakh STATE TIMES NEWS

UDHAMPUR: Four alleged drug peddlers were arrested along with narcotic substances including heroin in Udhampur district on Monday, police said.

Jeevan Kumar and Sunil Kumar, both residents of Jaganoo village, were arrested after 9.40 gm of heroin worth about Rs 6 lakh was recovered from their possession at Tikri on the Jammu-Srinagar national highway, a police spokesman said.

He said they were moving on a motorcycle when they were intercepted and sub jected to checking by police.

Two more peddlers, driver Sanjay Kumar and Rohit Kumar of Kah-Phalata vil lage, were arrested after 9.60 kg around Rs 1 lakh of poppy straw was recovered from their vehicle at Flata checkpoint in the Rehambal area, the spokesman said He said all four arrested peddlers were booked under the Narcotic Drugs and

Psychotropic Substances (NDPS) Act. The spokesman said police have so far registered 61 cases under NDPS since January this year in the district and arrested 87 accused, including seven under the stringent Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic

Substances (PIT-NDPS) Act. The spokesman said 22 vehicles used for the transportation of narcotics were

seized while six pharmacy shops were also attached for violating drug norms. As part of financial disruption, he said 43 bank accounts linked to drug ped dlers were frozen, involving an amount of Rs 16,72,948.

The seized contraband including heroin, charas, poppy straw and ganja during this period was valued at Rs 2.42 crore in the black market, the spokesman said adding police also attached properties worth Rs 4.69 crore, including multiple vehicles, residential houses and commercial assets related to both NDPS and

Police have also successfully secured convictions against 28 drug peddlers in 21 cases from courts, which marks the professional approach towards case investi gation and prosecution, the spokesman said.
