In other words, the largest youth population and the largest democracy. The prime minister asserted that the agreements signed during his tour will benefit Indian youth both within the country and abroad. The treaties cover critical sectors such as defence, pharmaceuticals, digital technology, energy, and rare earth minerals and will create far-reaching benefits.

"These initiatives will not only strengthen India's global economic standing but also generate meaningful opportunities for young Indians in both manufacturing and services," he said.

Noting that over 25 crore people were lifted out of poverty in the past 10 years, the prime minister said it would not have happened but for the employment and sources of income generated for them.

These poor people used to have a difficult living and feared death but became so strong that they defeated poverty, he added.

Citing an International Labour Organization report, Modi said over 90 crore people were covered under the ambit of welfare schemes in the last decade

India, based on its Gini index, is among the countries with the highest equality, ne said, underscoring his government's pro-people efforts.

Modi said his government's focus on boosting manufacturing has paid off, sayng electronic manufacturing has risen over five times to be worth Rs 11 lakh crore in 11 years and mobile manufacturing units number nearly 300 from two to four earlier.

Defence manufacturing is being discussed proudly after Operation Sindoor, he said in an apparent reference to the display of India's indigenous military capability during the conflict with Pakistan.

The worth of defence production has gone beyond Rs 1.25 lakh crore, he said, adding that India is now on its way to becoming the third-largest economy.

Modi said India has emerged as the largest locomotive producer in the world and rail and metro coaches have registered strong exports. The automobile sector, he added, has attracted USD 40 billion in FDI in just five years, resulting in new factories, new job opportunities, and record vehicle sales.

The government, he said, is also focusing on creating new employment opportunities as he referred to the Employment Linked Incentive Scheme, under which people in their first job in the private sector will be given Rs 15,000.

The government will contribute to the first salary of their first job and has allocated a budget of approximately Rs 1 lakh crore, he said, adding that it is expected to help in the creation of about 3.5 crore new jobs.

He stressed the transformative power of India's manufacturing sector in driving national growth, generating employment, and accelerating India's journey toward becoming the world's third-largest economy.

Appointment letters were distributed as part of the government's Rozgar Mela. The Rozgar Mela will play a significant role in providing meaningful opportunities to the youth for their empowerment and participation in nation-building, a government statement has said. Over 10 lakh recruitment letters have been issued so far under it, it said.

social justice along with political justice and ensure that the justice reaches to the last, most needy citizen of the country," he added.

Justice Gavai said he was greatly privileged to visit the Osmania University which had honoured Ambedkar with D.Litt in 1953.

In his address at the Nalsar University of Law, the Chief Justice also advised the passing out graduates to seek mentors for the sake of integrity and not for their power. On the "pressure to pursue a master's degree abroad", Justice Gavai said: "A foreign degree alone is not a stamp of your worth. Don't take this decision ir the reflex of thought or under your peer pressure. What happens next? Years of debt. anxiety, career decisions made under financial burden.

He cited examples of some young graduates or lawyers taking loans of as much as Rs 50-70 lakh for foreign education. In fact, a small portion of a big amount like Rs 50-Rs 70 lakh can be used as an investment to start independent practice or build an office chamber. The young lawyers can go abroad for studies at a later stage in life when they are stable, he said.

The growing trend of going abroad also reflects a structural issue, signalling a lack of confidence in the state of postgraduate legal education and research in our country, Justice Gavai said.

Many who study abroad come back with renewed passion and fresh perspectives but when they return, they often find institutions unwelcoming, under-resourced or close to new ideas. There are few structured pathways for postdoctoral research limited funding for early career scholars and opaque hiring processes that discourage even the most committed.

"This must change if we want to keep our best minds or bring them back. We must build nurturing academic environments, offer transparent and merit-based opportunities, and most importantly, restore dignity and purpose to legal research and training in India." he said.

On issues of mental pressure faced by legal professionals, he said the working hours are long, expectations are high and the culture sometimes is "ruthless".

"You will feel pressure, not just to succeed but also to appear to be successful. Many hide their struggles. I urge not to," he said.

It is not just enough to celebrate India's legal legacy; its future should be taken care of. The future depends on how researchers, young faculty and lawyers and scholars are treated.

Chief Minister A Revanth Reddy and Supreme Court Judge, Justice PS Narasimha also participated, while acting Chief Justice of Telangana High Court, Justice Sujoy Paul presided.

the airport perimeter, killing all but one of the 242 onboard and another 19 on the ground in the deadliest aviation accident in a decade.

The report did not provide any clues to why and by whom the two fuel switches were moved to a cut-off position as the plane nosed into the air, starving the two engines of the thrust needed for the lift. It ruled out any bird hit or fuel contamination

According to a chronology laid out in the report, both fuel cutoff switches moved from RUN to CUTOFF, one second apart, almost immediately after takeoff. Ram Air Turbine (RAT) pump was deployed to supply hydraulic power as both engines fell below the minimum idle rate.

About 10 seconds later, Engine 1 fuel cutoff switch moved to its so-called RUN position, followed by Engine  $\overline{2}$  four seconds later.

The pilots managed to relight both engines, but only Engine 1 recovered while Engine 2 failed to build up enough power again to reverse deceleration. One of the pilots issued a "Mayday, Mayday, Mayday" distress call, but before air traffic controllers could get a response about what had gone wrong, the plane crashed just outside the Ahmedabad airport boundary having grazed some trees before plunging into a hostel packed with students.

The time between the takeoff and the crash was only 32 seconds. The preliminary report recommended no action for now for the operators of Boeing 787-8 planes. In a statement, Air India said that it "stands in solidarity with the families and those affected" and "[continues] to mourn the loss" of those killed in the accident.

Air India said it was "working closely with stakeholders, including regulators" and "continue to fully cooperate with the AAIB and other authorities as their investigation progresses.

On its part, Boeing said: "Our thoughts remain with the loved ones of the passengers and crew on board Air India Flight 171, as well as everyone affected on the ground in Ahmedabad. We continue to support the investigation and our cus tomers.

The US National Transportation Safety Board noted that there were no recommended actions in the report aimed at operators of Boeing 787 jets or the GE engines

The ill-fated flight was commanded by Sumeet Sabharwal, 56, a veteran with 30 years of experience at Air India. He had logged 15,638 flying hours, including 8,596 on the Boeing 787. He was also an Air India instructor. His co-pilot was Clive Kunder, 32, who had 3,403 hours of total experience, with 1,128 hours or the Dreamliner.

Kunder was the pilot flying, while Sabharwal was the pilot monitoring. The crew had passed pre-flight breathalyser tests and were seen at the gate on

CCTV before they took off, the report adds. The June 12 accident was India's worst aviation disaster in almost three decades

and the industry's deadliest in 11 years, as well as the first fatal accident involving a Boeing Dreamliner.

The investigation was conducted with assistance from the UK's Air Accident Investigation Branch and the US National Transportation Safety Board.

Aviation experts have said it is difficult for pilots to inadvertently move the fuel witches as there is a little mechanical cate built into the switch. Switches need t be lifted up over this little gate to shut off supply. They also asked why the report made no reference to cockpit camera footage.

### Six narco smugglers nabbed with heroin STATE TIMES NEWS

KATHUA/UDHAMPUR: In its drive against drug smugglers and their propagators, Distric Police Kathua under the direction and overall supervision of SSP Kathua Shobhit Saksena has arrested 3 drug peddlers in the jurisdiction of Police Station Kathua and P/S Billawar and recovered about 10.55 Grams Heroin (Chitta) like substance( in two separate incidents) from their possession.

In the first instance, A Police team of PS Kathua led by PSI Subham Mahajan IC PP Hatli under the guidance of Addl. SP Kathua Sh. Rahul Charak JKPS and DySP Hqrs Kathua Sh Ravinder Singh, SHO PS Kathua Sh. Sandeep Chib while performing patrolling/vehicle checking, noticed one suspect who was coming from Berrian Pattan Link road towards National Highway 44 for selling heroin like narcotics.During frisking approximately 5.60 Grams of Heroin (Chitta) like substance was recovered from his possession who have been identified as:-Vineet Kumar S/o Sohan Lal R/o Ward No. 08 Kathua. Thereafter the accused person have been arrested along with contraband item was also seized. In this regard, a case FIR No. 333/2025 U/S 8/21/22/ NDPS Act Act has been registered at PS Kathua and inves tigation started.

Further, Justice Gavai said: "We see that in the journey of last 75 years, though there are many external aggressions, many internal disturbances, but India has always remained strong and united." Also, he said: "Let us all commit ourselves to taking forward the goal of framers of the Constitution in achieving economic and

Fuel switches are devices that regulate the flow of fuel into the engine of an aeroplane. Pilots use them to start or shut down engines on the ground or during a flight in case of an engine failure. They are spring-loaded to remain in position. To change fuel supply, a pilot has to first pull the switch up and then move it from RUN to CUTOFF or vice versa.

"The aircraft achieved the maximum recorded airspeed of 180 Knots IAS at about 08:08:42 UTC (13.38 IST) and immediately thereafter, the Engine 1 and Engine 2 fuel cutoff switches transitioned from RUN to CUTOFF position one after another with a time gap of 01 sec," the report said.

As per the report, the engine N1 and N2 began to decrease from their take-off values as the fuel supply to the engines was cut off.

"In the cockpit voice recording, one of the pilots is heard asking the other why did he cutoff. The other pilot responded that he did not do so," it said.

Almost immediately after the plane lifted off the ground, CCTV footage shows a backup energy source called a ram air turbine had deployed, indicating a loss of power from the engines

The report provided only a limited picture of the interaction between the two pilots in the flight deck.

The report said both fuel switches were found in the run position at the crash site and that there had been indications of both engines relighting before the low-altitude crash.

It said the aircraft took off at 08:08:39 UTC (13:38:39 IST) and at about 08:09:05 UTC (13:39:05 IST) one of the pilots transmitted 'MAYDAY MAYDAY MAYDAY'

"The ATCO (Air Traffic Controller) enquired about the call sign. ATCO did not get any response but observed the aircraft crashing outside the airport boundary and activated the emergency response," the report said.

AAIB also said fuel samples taken from bowsers and tanks used to refuel the air craft were tested at the DGCA (Directorate General of Civil Aviation) Lab and were found satisfactory.

The preliminary report was widely anticipated to throw more light on what could have led to the crash, which was one of the worst in India in decades, and also i was the first accident involving a Boeing 787 aircraft that resulted in hull loss.

The AAIB said the wreckage site activities, including drone photography/videography have been completed and the wreckage has been moved to a secure area near the airport. "Both engines were retrieved from the wreckage site and quarantined at a hangar in the airport. Components of interest for further examinations have been identified and quarantined," it said.

The AAIB is gathering additional details based on initial leads and data down loaded from the forward Enhanced Airborne Flight Recorder (EAFR) is being analysed.
