

# Patna-New Delhi Amrit Bharat train to start regular service from July 31: Northern Railway

NEW DELHI: The new non-AC Amrit Bharat Express between Patna and New Delhi to be inaugurated by Prime Minister Narendra Modi on Friday will offer regular service for travellers from July 31, the Northern Railway said.

"Train No. 22361 Rajendra Nagar Terminal - New Delhi Daily Amrit Bharat Express will commence its regular service from Rajendra Nagar Terminal on 31.07.2025. It will depart from Rajendra Nagar Terminal at 19.45 hrs daily and arrive at New Delhi at 13.10 hrs, the next day," Himanshu Shekhar Upadhyay, Chief Public Relations Officer, Northern Railway (NR) said on Friday.

He said in return, this train, numbered as 22362 New Delhi-Rajendra Nagar Terminal, will start

its regular service from New Delhi at 7.10 pm on August 1 and arrive at Rajendra Nagar Terminal at 11.45 am the next day.

"The train will operate daily from both stations in Up and Down direction from its scheduled timings," officials said.

After commencing its journey from Rajendra Nagar, this train has eight scheduled stoppages at stations such as Patna, Danapur, Ara, Buxar, Pt Deen Dayal Upadhyay, Dubedarganj, Govindpuri and Ghaziabad before it terminates at New Delhi.

"The train's stoppages will remain the same during the return journey," officials said.

Upadhyay said that the train will have eight sleeper class coaches, eleven general coaches, two luggage-cum-brake vans and one pantry.

According to the Northern Railway, one special Amrit

Bharat Express will make an inaugural run from Rajendra Nagar Terminal at 11.45 am on Friday to arrive in Delhi at 4 pm the

next day, halting at its scheduled stoppages. "Another special inaugural run has been also planned from New Delhi on

July 19, 2025 at 6 pm from Rajendra Nagar. The train will arrive at its terminating station at 11:45 pm the next day," Upadhyay said.

Consequent upon the declaration of the NEET UG- 2025 result by the National Testing Agency (NTA) on 14<sup>th</sup> of June, 2025 and subsequently notified by the Board vide Notification No. 073-BOPEE of 2025 dated 10.07.2025, the candidates belonging to the UT of J&K / Ladakh who have qualified the NEET-UG 2025 having scored the cut-off marks prescribed by the NTA and whose names figure in **Annexure-A** of the above referred notification and also the candidates whose names were not available in the said annexure but are the domiciles of J&K/ Ladakh and have submitted their documents in response to the aforementioned notification under reference forming **Annexure -A** to this Notification are hereby informed through the medium of this Notification to register themselves and upload the following documents online w. e. f. **18-07-2025 (10:00 am onwards) to 22-07-2025 (midnight)** so that Provisional UT Merit List (PUTML) of such eligible candidates belonging to UT of J&K/ Ladakh is prepared.

1. NEET-UG score card - 2025.
2. 10+2 Marks Card.
3. Domicile Certificate of UT of J&K / Ladakh (ST Category certificate in respect of candidates belonging to the UT of Ladakh).
4. \*Category Certificate, wherever required.
5. Date of Birth Certificate (Matriculation).
6. The candidates belonging to the UT of Ladakh are required to upload the Compulsory Service Bond (which shall be available in the Information Brochure to be uploaded by the Board on the official website ([www.jkbopee.gov.in](http://www.jkbopee.gov.in))).

\* OBC & EWS category certificates shall be as per the Performa prescribed for the UT of J&K.

The cut-off score for different categories is as under:

- a. Open Merit (including JKPM/CDP/Sports/EWS): 144
- b. Open Merit/EWS & PwD: 127
- c. SC/ST/STII/OBC/ALC/IB/RBA: 113
- d. SC/ST/STII/OBC/RBA/ALC/IB & PwD/ JKPM/Sports/CDP: 113

**NOTE:**

1. The candidates in their interest are advised not to use Mobile Phones for Registration purposes / uploading of documents.
2. The e-Information Brochure for NEET UG-2025 Courses shall be uploaded by the J&K BOPEE on its website in due course of time. The candidates are accordingly advised to go through the e-Information Brochure before registration.
3. No under-process certificates shall be entertained.
4. The cut-off date for validity of the category certificates shall be the last date for Registration fixed by the BOPEE, viz, 22-07-2025.
5. The candidate must fulfill all other criteria as laid down in the NEET-UG 2025 Information Brochure of NTA and Information Brochure of J&K BOPEE in respect of NEET UG- 2025 courses.
6. Candidates are allowed to participate in the counselling process based on qualifying the NEET cut-off score for different categories as mentioned above and also presuming that candidates fulfill all eligibility conditions as mentioned by the candidates at various stages of examination, registration, and counselling.
7. The candidates should enter their valid email as well as mobile number, as all important communications should be made with them on such emails/mobile numbers provided by them, whenever required by the Board.
8. Candidates, in their interest, are advised not to share their email password with other candidates/persons.
9. The Board shall not be responsible for any mistake made by the candidates while making the registration.
10. After completion of the registration process, the Board shall notify the Provisional UT Merit List (PUTML) of all the candidates, which shall be used for online counseling by the candidates (filling up of the preferences) based on which allotment of seats shall be made.
11. Any candidate who falls within the qualifying merit but does not register himself/herself shall not be considered for allotment of any seat.
12. The candidates, in their interests, are advised to go through the e-Information Brochure as and when uploaded by the Board on its website, viz. [www.jkbopee.gov.in](http://www.jkbopee.gov.in) and go through the technical and other instructions before registering themselves.
13. Since the admission in the Professional Colleges is time-bound, the candidates should not wait for the last date of registration, as it may be detrimental to the interest of the candidates(s).
14. The candidates who intend to participate against NRI/HM Quota seats in ASCOMS, Jammu shall also have to register online in pursuance of this notification; otherwise, they are not eligible for counselling under NRI/HM quota.
