ORDER

1. This order shall dispose of the instant application led by SHO concerned through APP for initiating proceeding under section 82 of Cr.P.C. Office report called. From the perusal of file it reflects that accused remained absent from many dates of hearing, wide order dated 10.10.2024, this Court after recording statement of tamfil, which shows his inability to execute the warrant against the accused and also submitted that there is no future prospect there are bleak chances for his apprehension. Accordingly proceeding under 512 Cr.P.C. initiated against the accused and NBW in triplicate i.e. (Warrant Gashiti) was issued against the accused and file consigned to record. Thereafter, on 10.04.2025, SHO moved an instant application for proceeding under section 82 Cr.P.C. File recalled from record and accordingly NBW in triplicate (i.e. Warrant Gashiti) issued against accused is hereby recalled and file is taken up for further adjudication as per mandate provided in Section 82 Cr.P.C. But a very astonishing fact about this file is laying of motion on the part of SHO Katra for proceeding under section 82 Cr.P.C. is quiet late and nowhere in his application he has explained his delay nor assigned any reason what stops him to approach this Court for proceeding under section 82 Cr.P.C. This shows very casual approach on the part of Police concerned as on the one hand it is their own executing section i.e. tamfil concerned draw their satisfaction for their inability to apprehend the accused and once this Court proceed under section 512, they wake up and led this motion which they were supposed to do so at the beginning when they repetitively failed to apprehend the accused in person and execution of warrant i.e. Bailable Warrant and Non-Railable Warrant.

2. From above, it transpires that accused is absconding and concealing himself so as to prevent execution of warrant and I am satisfied that proceedings for compelling appearance of accused including proclamation is required to be invoked against accused. Accordingly office is directed to issue proclamation against the accused requiring and directing him to attend this court on 30.06.2025 at 10 am sharp.

3. SHO Katra shall get the proclamation published as follows:
i. It shall be publically read in some conspicuous place of the town in which accused is ordinarily resides;
ii. It shall be affixed to some conspicuous part of the house or home stead in which accused person is ordinarily resides.
iii. A copy of thereof shall be affixed to some conspicuous part of Court i.e. Notice Board of this Court.
iv. SHO Katra is further directed to get it published in a daily newspaper (both English and Hindi edition) i.e. Daily Excelsior and prominent Hindi newspaper which is having circulation in the area where accused ordinarily resides.

4. SHO Katra shall furnish photographs evidencing the police officials that proclamation is read in conspicuous place and while affixing the proclamation as per direction (i) and (ii) above and he is further directed to ensure the compliance and submit report and shall ensure that proclamation be published in the above mentioned newspaper by next date i.e. 30.06.2025 and furnish both the newspapers to this Court.

5. Office is directed to issue fresh NBW of arrest against accused which shall remain in force until cancelled by this Court and SHO Katra is again authorized to arrest the accused anywhere in India after conducting inquiry of his whereabouts.

6. SHO Katra shall furnish whole newspapers and not only cutting m which proclamation is published. Put up on 30.06.2025.
