CBI Court adjourns case of Kiru Hydropower Corruption Case

JAMMU: In the much publicized case in which the CBI had filed chargesheet against former Jammu and Kashmir Governor Satyapal Malik and Navin Kumar Choudhary, IAS, the then Chairman, CVPPPL; Rupen Pravin Patel (since expired); M/s Patel Engineering Pvt. Ltd. Through its Director; Muthirakkalayil Samuel Babu; Mahesh Kumar Mittal; Arun Kumar Mishra; Virender Singh Rana; Kanwar Singh Rana and Kawaljit Singh Duggalin connection with alleged corruption in the award of Rs 2,200-crore civil works for Kiru hydropower project, Special Judge CBI Jammu Pawan Sharma adjourn the case for the September 4, 2025.

Today when the case came-up for hearing PP was present for CBI. Sr.

Adv K.S Johal, along with Adv Devansh Thakur, is present and filed Vakalatnama on behalf of Kanwar Singh Rana. Court directed PP for the CBI to provide a copy of the chargesheet to counsel for the accused. PP has submitted that Sanction in the case is still awaited and submitted that he shall submit the sanction report on or before the next date of hearing. Upon this Court adjourned the case September 4, 2025. It is worthwhile to mention here that the letter written by Dr. Mohammad Usman Khan, KAS, Deputy Secretary, GAD, Govt of J&K, vide letter No. GAD-VIGOMISC/2/2022-07-GAD dated 23.03.2022, has conveyed the decision of Govt. of J&K, for investigation by CBI into allegations of malpractices in

award of contract, in respect of civil works of Kiru Hydroelectric Power Project, on the basis of reports of Anti Corruption Bureau, UT of J&K and Power Development Department, Govt. of J&K. The reports of Anti Corruption Bureau, UT of J&K and Power Development Department, Govt. of J&K are enclosed as Annexure-B (Page Nos. 29 to 34 enclosed with the said letter of Deputy Secretary, GAD) & Annexure-C (Page Nos. 35 to 55 enclosed with the said letter) respectively. Perusal of these reports reveals that in award of Civil Works package of Kiru Hydroelectric Project, guidelines regarding e-tendering were not followed and though a decision was taken in 47th Board Meeting of CVPP-

PL (Chenab Valley Power Projects (P) Ltd.) for re-tender through e-tendering with reverse auction, after cancellation of ongoing tendering process, same was not implemented (as per decision taken in the 48th Board meeting) and tender was finally awarded to M/s Patel Engineering Ltd. Therefore, a regular case is registered against Navin Kumar Choudhary, IAS, the then Chairman, CVPPPL MS Babu, the then MD, CVPPPL, MK Mittal, the then Director, CVPPPL; Arun Kumar Mishra, the then Director, CVPPPL; M/s Patel Engineering Ltd. and unknown others under Section 120-B RPC r/w 5(1)(d) r/w 5(2) of the J&K PC Act, Samvat, 2006 and is entrusted to Mahesh Kumar, ASP, CBI, ACB, Jammu for investigation.

DB orders demolition of Commercial building in Srinagar

JAMMU: A Division Bench of the High Court of Jammu & Kashmir and Ladakh, comprising Justice Sanjeev Kumar and Justice Sanjay Parihar, has directed the Srinagar Development Authority (SDA) to demolish an unauthorized structure, even if it involves demolition of the entire building. The Court has instructed the SDA to submit a compliance report within two months. This directive came while dismissing a Letters Patent Appeal (LPA) filed by Mohamad Rafiq Sheikh and Bashir Ahmad Sheikh, challenging the judgment dated August 3, 2023, passed by a Single Judge in OWP No. 203/2017. The writ peti-

tion had set aside an earlier order of the Jammu and Kashmir Special Tribunal dated January 23, 2017, which had compounded building violations committed by the appellants. The appellants and their father had obtained separate building permissions from the SDA for constructing three individual Guest Houses/Hostels on their proprietary land. However, instead of adhering to the sanctioned plans and maintaining a 30-foot setback between the buildings, the petitioners illegally merged the three structures into one, violating setback norms. These violations were significant and brought to the attention of the authorities, including the police. The Division Bench held

that the violations were not minor and therefore not compoundable under either the 1998 or the Revised 2001 Building Regulations. The Court emphasized that both Regulations explicitly exclude violations in required setbacks from the purview of compounding by the Tribunal. The Tribunal, it noted, had failed to appreciate the legal position and had been influenced by irrelevant considerations. Expressing concern over unregulated urban development, the Court observed that such violations are rampant in Srinagar and have led to chaos, traffic congestion, and environmental degradation, including the devastating 2014 floods. The

judges criticized the laxity of building control authorities and called for stricter enforcement and accountability, including penal provisions for officials who allow unauthorized constructions. The Bench rejected the argument that similar illegal structures exist elsewhere, asserting that enforcement must begin somewhere. The judgment directs the SDA to proceed with demolition as per law and places the responsibility on the Registry to forward a copy to the Chief Secretary of the Union Territory. This ruling reinforces judicial resolve to curb unauthorized construction and promote orderly urban development in Srinagar.
