

## NIA Court acquits Dy Suptt Jail, others

**JAMMU:** Special Judge NIA Jammu Sandeep Gandotra acquitted Sohail Ahmed Bhat, son of Ghulam Mohi-Ud-Din Bhat, resident of village Dogripora, Awantipora, Pulwama and Daulat Ali Mughal, son of Syed Rehman Mughal, resident of Kupwara are acquitted of the charges leveled against them under Sections 13, 18, 39 UA (P) Act; accused Mohd Ishaq Palla, son of Ghulam Rasool, resident of Aloora, Shopian is acquitted of the charges leveled against him under Sections 13, 18, 18-B, 20 & 38 UA (P) Act; and accused Deputy Jail Superintendent, Feroz Ahmed Lone, son of Abdul Gaffar Lone, resident of Phakerpora, Charar-i-Sharief, Badgam is acquitted of offenses under Sections 18 & 39 UA (P) Act.

While acquitting accused from the charges, Court observed that in view of the detailed discussion made herein above, the uncorroborated, contradictory & infirm statements made by the witnesses and IOs, relied upon by the prosecution, have failed to inspire confidence in the mind of this court to convict the accused persons. The prosecution has, therefore, not been able to prove by cogent and reliable evidence the charges which have been made against the accused persons.

While acquitting the accused persons, Special Judge NIA Sandeep Gandotra observed that before parting it needs to be reiterated with a heavy heart that from the statements of PW-II, PW-III, PW-IV, PW-XV and PW-XXV it is clear that there was no discipline and control over the inmates in Central Jail Srinagar on the date of occurrence i.e. October 25, 2017. It has also come on record in their statements that all the

inmates used to meet other inmates and visitors at their own will. PW-IV Manzoor Ahmed Dar has stated that the inmates used to do whatever they wished & the officers knew these facts but the officers were helpless and they could not do anything. Even the Superintendent of jail PW-XXV has admitted this fact. This is a very sad reflection on the working of officers and officials of Central Jail Srinagar for which accountability needs to be fixed and it shall be ensured that such a situation does not arise in future.

A word of caution for the investigating officers as well. According to PW-XVII SP Sudhanshu Verma no document was prepared at the time when accused persons A1 & A2 were taken in custody for questioning under section 54 Cr.PC on 21/10/2017. He has also stated that he had recorded the confessional statements of accused persons A 1 and A 2 and handed them over to NIA but no such confession statements are part of record. The CIO PW-XXXI SP Vishal Garg has admitted that he has not placed on record the order vide which he had made 20 teams for search of Central Jail Srinagar. He has also stated that since accused A4 Ishaq Palla was not lodged in Central Jail Srinagar at the time of search therefore none of the recovered articles were recovered from the possession of Ishaq Palla. He has also admitted that he has not attached a copy of Malkhana register with the challan. He could not explain as to how come the last activity in the mobile phone of accused A2 Sohail Ahmed was of 24/11/2017 whereas said mobile was in custody of police since 25th of October 2015 and seized on 30/10/2015. Strangely, the CIO PW-XXXI SP Vishal Garg has admitted in his cross-examination that

it has not come in his investigation from the statement of any witness that accused persons in furtherance of a criminal conspiracy were looking to commit a terrorist act. It appears that the investigation was flawed which has impacted the case. Crucial evidence has not been collected and there is tampering with evidence while in custody of police. It is expected from the investigating officers to conduct the investigation thoroughly and professionally, more so when the country is facing a hostile neighbor who is hell bent to vitiate the atmosphere by committing barbaric acts of terrorism like the one recently committed at Baisaran Valley Pahalgam.

On October 30, 2017, SI Harvinder Singh 09274/ARP with police staff and components of 98 Bn CRPF were deputed to perform cordon and search duty in Manigah area District Kupwara on an information that some terrorist have taken shelter and hidden themselves. Two persons Danish Ghulam Lone (A-1), son of Ghulam Mohd Lone, resident of Braw Bandina, Tehsil Litter, Pulwama, J&K and Sohail Ahmed Bhat (A-2), son of Gulam Mohi ud din Bhat, resident of Dogripora, Awantipora, Pulwama J&K were apprehended.

During initial inquiry, it revealed that with the connivance and support of other accused persons including but not limited to Daulat Ali Mugal (A-3), Ishaq Palla (A-4), Liyakat Ali Khan (A-6) etc, they were trying to cross the Line of Control (LOC) and to enter Pakistan Occupied Kashmir (POK) for arms training with criminal intention to wage war against state. Accordingly PS Kupwara registered a Case No. 279/2017 dated October 30, 2017 under Section 120B of RPC and 13, 18 & 18-B of Unlawful

Activities (Prevention) Act, 1967.

The investigation was launched by the IO Kupwara Police and further accused Daulat Ali Mugal (A-3), Liyakat Ali Khan (A-6), Haroon Ahmed Sheikh (A-7) and Gulam Nabi Mugal (A-8) were arrested in this case.

The Central Government on receipt of information of above case under Unlawful Activities (Prevention) Act, 1967, directed NIA as per the provisions contained in sub section 5 of section 6 read with section 8 of NIA Act, 2008, MHA, New Delhi vide Order No. 11011/12/2018/NIA Dated February 19, 2018 to take up the investigation of this case. Accordingly, the aforesaid Kupwara case was re-registered in PS NIA, New Delhi vide Case No. RC-07/2018/NIA/DLI Dated February 21, 2018 under sections 120B RPC and Sections 13, 18 & 18-B of Unlawful Activities (Prevention) Act 1967 against the accused persons.

The case also pertains to an attempt by accused persons Suhail Ahmad Bhat and Danish Ghulam Lone, who were arrested earlier, to travel to POK for arms training for waging war against the State. They were motivated by Ishaq Palla. At the time of incident, Ishaq Palla was lodged in Central prison Srinagar in a different case and he was instrumental in hatching the conspiracy from Jail. In this conspiracy, he was actively assisted by Feroze Ahmad Lone, who was posted as Deputy Jail Superintendent Central Jail Srinagar at that time. The conspiracy meeting at the central prison Srinagar was held on 25 October 2017. Accused persons were in contact with each other through blackberry messenger during whole of October before they were apprehended by the police on 30 Oct 2017.
