JAMMU: To highlight various problems faced by dairy farmers due to issue of lumpy skin disease in cattle, Jammu & Kashmir Dairy Farmers Association has urged the administration to initiate measures for redressing grievance of farmers besides taking measures to resolve the issue at the earliest. While addressing media during a press conference, President JKDFDA Kulbushan Khajuria along with other senior members of association demanded immediate measures to stop induction of cattle from neighboring States so that infected animals may not enter J&K. They further demanded for convening a high-level meet of concerned authorities such as Vice chancellors of Agriculture Universities, Animal Husbandry Department and veterinary scientists to discuss and provide solutions for the fast-spreading disease. "As the disease has no treatment yet and is spreading fast, therefore, strict measures similar to that taken to contain COVID-19 should be initiated for saving live-stock," he added, demanding adequate compensation for farmers who lost their animals due to disease.


