2. Candidate may choose to submit all the preferences available

OR

Candidate may choose not to submit preference for all the institutions i.e. he/she is interested to take admission in only one/more institutions (which has been selected by him/her) and is opting out for the other available institutions/options.

In such a case where the candidate is not allotted the institution of choice on merit-cum-preference basis and has not opted for rest of the available institutions, Mission Youth shall drop the name of the candidate from the final selection list.

3. Submission of preference shall in no way entitle a candidate for final selection. Final selection and allotment of institute shall be based on the outcome of the document verification of provisional candidates and female candidate (score b/w 75 and 99).

For and on behalf of the Lieutenant Governor of Union Territory of Jammu & Kashmir, Divisional Forest Officer, Kishtwar, District Kishtwar invites e-tenders from approved and eligible contractors registered with Govt. of Jammu and Kashmir Union Territory /Central Govt. Organizations for the following works:-

Name of Work:-

i. **Fencing work**:-Erection of fencing line using1000 fence posts at spacing of 8feet& 4 strands of Black Annealed Barbed wire.

ii. **DRSM Work**:- Cost and carriage of stones, preparation of foundation with minimum depth of 1.5 feet projected 6 inches extra at ground level duly leveled for Construction of retaining walls(Dangas) in Dry Rubble Stone Masonry of desired height and width as per site demand. Numbering and Preparation of sign board including writing with green and white paint.

Fencing work:- The key materials, like, Black Annealed Barbed wire, paint, brush, nails, ladder & Sign board etc. will be procured by contractor itself. The contractor shall ensure quality of fencing material as per the specifications mentioned in the tender documents. **Successful bidder shall seek a quality certificate in respect of Barbed Wire from SICOP/Authorized agency and passed certificate from the verifying committee formed by this Division on spot physical inspection of the material before using of the same**.Further, in respect of wooden fence posts, these shall be provided from the available material in nearby forest compartment duly extracted under the close supervision of Range Forest Officer concerned. The Contractor will have to pay the extraction charges directly to the beneficiary on DBT mode against bill prepared by concerned Range Officer on the basis of prevailing timber/firewood extraction and wage rates which in no case will be more than Rs100/wooden post. Final payment to the Contractor shall be made only after ascertaining the receipt of payment by beneficiaries. Further, the fencing shall be completed by the contractor before commencement of planting season which usually starts with first shower during first week of November.

i. **DRSM Work**:- The stones to be used in construction of retaining walls(DRSM Work) will be procured by the contractor himself, no quarry will be allowed in forest area.

ii. The work order will be accorded in favour of the successful bidder(L1) only after receiving of Test Check Report of the material issued by the SICOP and verification certificate from Verifying Committee and deposit of earnest money, cost of tender, additional security deposit whatever applicable along with all other requisite documents etc. etc.
