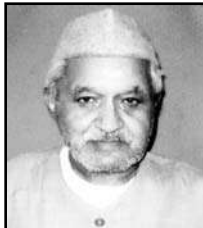

CRIME REPORT

Youth found hanging in guest-house

KATRA: A youth was found hanging in a guest house at Banganga area of Katra on Tuesday.

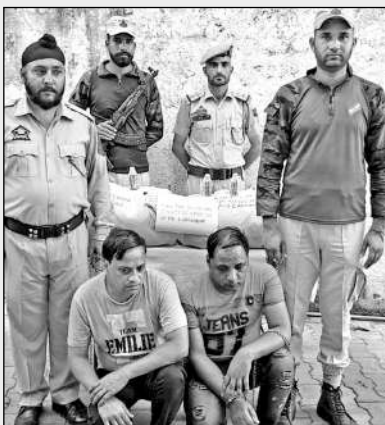
As per details, some locals, on noticing a youth hanging in room of Gurdalay Guest House near Banganga, informed owner of guest house who along with police rushed to the spot. Police took body into custody and shifted it to morgue. The deceased was identified as Rahul Kumar, son of Devraj, resident of Dansal.

Major drug smuggling bid foiled; 3 arrested, 400 bottles of corex, 970 intoxicating injections/ tablets recovered

KATHUA: Acting sternly against drug menace and its propagators, District Police Kathua on directions of SSP R C Kotwal, arrested three drug peddlers at Lakhampur and recovered/seized 400 Bottles of Corex (Codeine Phosphate & Chlorpheniramine Maleate syrup), 170 intoxicating injections along with 800 Tapentadol tablets from their possession and seized a bus.

As per details, acting on information that two drug-peddlers namely Nadeem, son of Mohd Shabim and Shakeel, son of Mohd Shabir, both residents of Qureshi Nagar, Delhi, who were involved in drug peddling, are coming from Delhi towards



J&K UT in a bus (UP81CT-3952) and carrying a huge quantity of contraband. Accordingly, a police party led by Insp Vijay Kotwal SHO Police Station Lakhampur under the supervision of DySP DAR Kathua Sukhdev Singh laid special Naka/checking duty at Lakhampur (NHV) and nabbed both persons near NHW Lakhampur from a bus. On thorough checking, 400 bottles of Corex (Codeine Phosphate & Chlorpheniramine Maleate syrup 100 ml each) were recovered from their illegal possession. On questioning, both accused revealed that the consignment was being brought towards J&K UT. On this both the accused were arrested and bus along with recovered material was seized. FIR No. 75/2022 under sections 08/21/22 of NDPS Act was registered at Police Station Lakhampur and investigation started.

While in second instance, a team from Police Station Lakhampur during Naka checking duty apprehended a suspect. On checking, 60 injections of Promethazine Hydrochloride, 94 Diazepam injections, 16 Buprenorphine Injections making a total of 170 injections along with 800 Tapentadol Tablets (75 mg each) were recovered from an accused namely Sumit Sharma, son of Omkar Sharma, resident of Malani Tehsil Bhadarwah, at present Toph Sherkanian. FIR No. 76/2022 under sections 8/21/22 of NDPS Act was registered at Police Station Lakhampur and further investigation started.

2 drug-peddlers arrested, contraband recovered

HANDWARA: Continuing efforts to eradicate menace of drugs, Police on Tuesday arrested two drug peddlers in Handwara and recovered contraband substances from their possession.

As per details, a party of Police Station Vilgam at a checkpoint established at Dahama crossing intercepted 2 persons. During checking, officers recovered 800 gm Charas like substance from their possession.

The accused, identified as Mohd Gulzar Mir, son of Gh Mohi Ud Din Mir, resident of Amargad and Basit Ahmad Rather, son of Abdul Gaffer Rather, resident of Amargad Sherokote, were arrested & shifted to police station where they remained in custody.

Accordingly, FIR No. 95/2022 under relevant sections of law was registered at Police Station Vilgam and further investigation started.

Missing woman, girl traced

RAMBAN: Police on Tuesday traced out a missing woman and a girl.

As per details, on August 21, a complaint was lodged by a man, resident of Ludhwal Batote stating that his 27 years old wife went missing from house since August 11. Accordingly, a missing report was registered and a team was deputed to trace out missing woman. After hectic efforts, the woman was traced out by Police station Batote within 24 hours from Dhal with help of cyber team of Ramban Police. She was later handed-over to her husband after completion of all legal formalities. The overall efforts were made by police party headed by ASI Roshan Lal under command of Insp Rakesh Jamwal SHO Batote, under supervision of Pardeep Singh Sen Dy.SP HQ Ramban with the overall supervision of SSP Ramban, Mohita Sharma.

Meanwhile, a complaint regarding missing of a girl was lodged at Police Station Miran Sahib by a person, resident of Bareilly.

He stated that her sister went missing since morning. Accordingly, a missing report was registered and investigation initiated. To trace out missing girl, a team was constituted by SP Hqrs Rannish Gupta under supervision of SDPO R S Pura Surinder Singh.

The team led by SHO Miran Sahib Insp Zaheer Mushtaq, after putting in hectic efforts and with help of technical assistances, traced missing girl within 24 hours safely. Subsequently, family of missing girl was informed and she was handed over to family members after completing all legal formalities.

Man booked for spreading rumours
