JAMMU: District Administration Jammu, under the guidance of District Development Commissioner, Avny Lavasa, on Wednesday established a C-DYTE Centre in far flung Sub Division Chowki Choura.

The land acquiring agency i.e MoRTH has placed the requisite amount of compensation at the disposal of the undersigned. Notices have also been issued to the concerned land owners/ interested persons as required under Section 3 E of the NH Act, 1956.

Accordingly, ali the concerned land owners/ interested persons are hereby informed/ notified through this additional public Notice that the compensation amount is hereby offered to ali such land owners. Further, it may be noted that:

- The compensation amount in respect of ali such land owners, who have already submitted their Bank account details, is being credited to their respective Bank Accounts through RTGS.

It may further be noted that since the amount of compensation has been determined and tendered to the concerned land owners/ persons interested therein through this additional public notice, any failure to collect the compensation amount would be to their account and the amount shall be deemed to have been paid on expiry of this period of sixty days from the date of publication of this notice.

The land owners/ persons interested therein are further called upon to surrender or deliver the possession of the subject land to the undersigned, failing which the possession of subject land will be taken with police assistance on expiry of the period of 60 days.

- Any candidate who fails to submit their deficient documents within the last date i.e. 30-08-2022 upto 04:00 P.M. fixed by Board, his/her candidature shall be automatically cancelled and shall not be considered to participate in Counselling process / admission in any case.
- Candidates who have applied under Spots category but their names are not recommended by J&K Sports Council shall be converted into OM (Open Merit) category.
- The candidate(s) who have uploaded their expired category certificates or more than one category certificates, are advised to submit their valid category certificate issued by the Competent Authority, physically at BOPEE office Jammu/ Srinagar upto the last date mentioned in this notice, subject to the condition that their Category certificate should have been issued by the competent authority by or before the last date i.e.21-04-2022, fixed by the Board for filling up of online application forms as mentioned in various Notification/ Notice/e-information brochure available on BOPEE website.
