## SMC fails to tackle menace of stray animals

SRINAGAR: Srinagar Municipal Corporation (SMC) has failed to prevent movement of stray animals on city roads, stray dogs, horses, cows etc thereby posing risk of accidents to pedestrians & motorists. Residents of several areas in summer capital often complain about presence of stray animals on roads, many times resulting in accidents. Residents of variincluding Bemina, Barzulla, Rawalpora, Lal Bazar, Bota Kadal, Alamgari Nowhatta, Khanyar, Bagaate Shoor Umer Colony, Saderbal, Bypass and Sanat Nagar etc have said that increasing population of stray animals hamper vehicular and pedestrian movement. "Stray animals stand in middle of roads, bringing entire traffic to halt at times. Dozens of animals like cows and calves keep roaming in localities

Sometimes they move in herd posing risk to pedestrians." said residents of Bagaate shoor area of Lal Bazar. "Problem is growing with each passing day. The authorities seem to have run out of options to address the menace," said commuters of Lal Bazar and adjacent areas, adding that in some areas of Srinagar, stray animals even enter premises of

their houses.

in April Earlier, Srinagar district administration ordered for setting up of Animal Rescue Centres to rescue stray animals. This centre was a most-needed project for residents of Srinagar city as there are hundreds of stray animals which are often sitting in middle of the main roads and many times create huge traffic jams. To set Animal Rescue Centre a place was identified Athwaian area and land was recently transferred to Animal Husbandry

Joint commissioner SMC told that Corporation is already working on curbing stray dog menace and for rescue/rehabilitation of animals can join hands the concerned Department to multiply efforts, but it was observed that SMC failed to restrict movement of stray animals on roads in summer capital posing risk of accidents for commuters.

SMC veterinary section also claimed that they are collecting fines relating to allowing stray animals roam on roads, and many inform owners making them aware of the issue. "Other strav animals are being lifted and owners of the animals are penalized under rules, while abandoned animals are being shifted to cattle pound,' said Joint commissioner SMC, adding, "We are looking at a programme for rehabilitation of such animals so that this issue can

JAMMU: In a significant development, CJM Jammu Amarjeet Singh Langeh has issued Non-Bailable Warrants against accused PSI Rahul Sharma, Incharge Police Post Panjtirthi, as he failed to appear in the Court in a criminal complaint filed by an Advocate. The Court, after taking congnizance, issued summons against accused PSI Rahul Sharma through SHO Police Station Pacca Danga. It may be recalled that earlier also on a date of hearing, accused PSI Rahul Sharma had failed to appear in the Court and due to his non-appearance, the Court of Chief Judicial Magistrate, Jammu had issued Bailable warrants amounting to Rs 10,000 against him

Jammu. Accused PSI Rahul Sharma was earlier released on bail by Court in the complaint on furnishing surety and personal bonds to the tune of Rs 15,000 as an assurance to court that he shall appear on each and every date of hearing in the case. Since, Advocates have abstained from work as a part of their ongoing strike, none of the Advocates were present either for complainant or the accused. However, complainant was present in-person before the court whereas accused chose to remain absent again on this date of hearing before the Court. # Jammu Admn initiates string of measures to prevent, control spread of LSD

JAMMU: Under the supervision of Deputy Commissioner Jammu Avny Lavasa, the District Administration has taken a string of measures to prevent, control and contain the spread of Lumpy Skin disease in the animals.

The District Administration has been organising a series of camps, besides providing door to door treatment to the affected dairy animals. The District Administration has also issued a set of advisory to prevent and control the spread of disease among the animals.

According to a public notice order, the administration has banned the movement, transportation of dairy animals from one place to another. The movement of all trucks/tractor trolleys/other vehicles carrying animals/cattle in/out/within the district shall be stopped with immediate effect.

The order further says that to check the spread of the LSD disease, infected animals are to be isolated from healthy stock. Also, carcasses of animals are not to be disposed of in the open and skinning of carcasses is also prohibited.

Animal carcasses are to be disposed of in two days under the supervision of officials of the Animal Husbandry department as per protocol.

The order said that cleaning and disinfection of the infected premises/ shed shall be done by using phenol/sodium hypochlorite/fromalin. It also said that in case of emergency the people should seek immediate help from the nearest veterinary centre for treatment.

The District Administration has also issued a helpline number 18001807205 for the farmers.
