According to reports, Patwaris of District assembled at Udhampur Headquarters staged protest in favour of their demands

which include providing infrastructure for digitisation, DPC, creation of new Patwar Halqas, increase in promotion quota for the post of Naib Tehsildar and pay grade Rs 2800. "Govt. put all Patwaris under 2400 grade pay which is totally unjustified" they rued and further stated that UT body decided to defer strike for period of three weeks as
