Illegal mining causing serious impact on natural resources, tourism

SRINAGAR: Illegal mining is not causing a threat to natural resources but it can also affect tourism industry in Kashmir, as at many places it has been observed that mining is not emerging a major challenge for natural resources but also causing grave threat to several historic places of Valley. Illegal mining, which is going on unabated in North to South Kashmir, has endangered heritage and ancient monuments, besides posing threat to highway bridges and other adjacent areas.

Ganderbal, "Mining activities are threatening nearby tourist places and other tracks which have been particularly reserved for adventure tourism. Despite tall claims by local administration and Mining Department, a large number of mules can be seen carrying extracted sand and gravel from river banks. Several sand and gravel dumps could be seen on Srinagar-Baramulla highway, Srinagar-Ganderbal road and Srinagar-Budgam road. Deep trenches dug by mining mafia in riverbed had weakened ancient monuments as well as pillars of bridges."

They further said that in view of emerging scenario, a complete ban should be imposed on mining in Kashmir valley. As per Government's instructions, mining cannot be carried out within 100 mts of a bridge but mining mafia is engaged in illegal activity right next to foundation of several bridges and other natural resources. A few residents also claimed that despite highlighting the issue several times, mining authorities and local administration has done nothing in this regard. Government must come up with a proper policy on extraction of minerals like sand in UT and ensure that licenses are granted on the basis of merit. All vehicles ferrying mineral illegally extracted or obtained must be seized. Moreover, all loopholes in system, of which the mining mafia take advantage, need to be plugged. Govt and other concerned authorities need to expedite efforts to curb illegal mining activities in UT, in the larger interest of people."

JAMMU: Deputy Commissioner Jammu, Avny Lavasa on Tuesday asked for cancellation of registration of Vehicles found involved in illegal mining of minor minerals.

She was chairing the meeting of the Multi-Departmental District Level Task Force Cell constituted to coordinate in plugging the illegal extraction and

transportation of minor minerals. The meeting was convened to review the enforcement measures to contain the illegal mining and other issues in the district.

ADC L&O Minga Sherpa; SP (Hr) Rammish Gupta; DMO Dr. Gulshan Kumar along with senior officers from concerned departments were present in the meeting.

It was decided in the meeting that registration of the vehicles indulging in repeated violation shall be cancelled.

The meeting further recommended strict action against the vehicles involved in road side dumping of the construction material and muck. The Deputy Commissioner directed the concerned officials to strengthen check naks at the vulnerable points to tighten noose around the perpetrators of illegal mining. She further directed the concerned officers to remove the encroachments alongside Tawi River and keep close check on the extraction of minor minerals along its banks. She asked the concerned officers to take strict action against the violators and book them under the prescribed sections of the Law.

JAMMU: The spate of resignations in the Jammu and Kashmir Congress continued unabated with 64 more leaders including a former deputy chief minister tendering their resignation and joining the Ghulam Nabi Azad camp on Tuesday, leaving the unit of the national party in the Union Territory in tatters. Led by former Deputy Chief Minister Tara Chand, the leaders in their joint resignation letter to Congress president Sonia Gandhi said "all of us had a very long association with the party spanning over decades...but unfortunately we found that the treatment meted out to us was humiliating."

Chand, along with others 64 Congress men and senior functionaries including former ministers Abdul Majid Wani, Manohar Lal Sharma, Gharu Ram and former MLA Balwan Singh, announced their resignations from the Congress at a press conference here on Tuesday.

Further, the JK Bank was asked to raise public awareness among its users through text messages, especially with respect to the 12th installment of the PM KISAN Yojana, which will be credited directly into the Aadhar-seeded bank accounts of registered farmers through direct benefit transfer. Besides, Divisional Commissioners of both divisions were asked to rope in public representatives and concerned line departments in expediting the collection of requisite scheme-related data.

For raising awareness on the mandatory Aadhar-seeding and authentication of beneficiaries under various government schemes, Dr. Mehta asked the Information Department to run dedicated advertisement campaigns in all vernacular newspapers.

It was informed that a month-long 'Nash Mukt Abhiyan' will be organized across Jammu and Kashmir, commencing from 1st September, 2022. It is estimated that a total of 06 lakh victims are associated with activities related to drug and sub-

stance abuse in the Union territory.

Accordingly, the Social Welfare Department was asked to generate a database of all such victims through the Panchayati Raj Institutions in collaboration with the teams from Rural Development and Health & Medical Education departments along with district administrations, by 15.09.2022.

The Department was advised to extend medical care and rehabilitation to the identified victims while maintaining their anonymity and treat them as patients and not criminals.

Further, to strengthen the infrastructural support to the campaign, all district administrations were directed to establish a drug de-addiction centre at respective district hospitals with adequate arrangements for professional manpower and medical supplies. The Home Department was also asked to organize monthly meetings of District Narcos Task Forces to tighten the noose against the drug peddlers and dealers.

Furthermore, the concerned departments were asked to ensure completion of Amrit Sarovar and

Swachh Gram Abhiyan within their stipulated timeframes. The district administrations were asked to submit the progress of developmental works to be completed during the current fiscal under the District CAPEX, besides giving a fillip to the self-employment schemes in their districts for greater employment generation.

The Chief Secretary asked the Divisional Commissioner, Kashmir to ensure that all places in Kashmir valley remain open and connected throughout the winter season as the region is receiving an unprecedented number of tourists. Similarly, the Divisional Commissioner, Jammu was asked to spruce up tourist destinations and promote tourism in Jammu region especially the Mansar-Surinsar circuit, Bani-Sarthal circuit, and Bhaderwah-Sinthal circuit, besides various other regional tourist attractions and destinations.

It was further informed that the 'Back-to-Village-4' will be organized shortly for which all district administrations were asked to prepare fully.

Prisoner doesn't cease to be human, entitled to all fundamental rights in jail: Justice Magrey

SRINAGAR: Executive Chairman J&K Legal Services Authority, Justice Ali Mohammad Magrey on Tuesday chaired a high level meeting to discuss ensuring that the undertrials/convicts are not denied the basic fundamental rights, while they are in custody.

The meeting was attended by Additional Chief Secretary Home, R. K. Goyal; DG Prisons, H. K. Lohia; Principal Secretary Estates Department, Alok Kumar, Secretary Law, Justice & Parliamentary Affairs, Achal Sethi and Member Secretary, J&K LSA, M. K. Sharma.

During the meeting, ACS Home apprised Justice Magrey about the existing

facilities available for the detainees in different prisons of J&K and the improvements made in the near past.

It was informed that against the sanctioned capacity of 3629 in 14 jails of the UT of J&K there are as many as 5148 inmates. Therefore, the average occupancy rate of prisons in J&K is 142%.

However, it was informed

that the government is considering the raising of infrastructure to ensure decongestion in jails. Justice Magrey was further informed that in the year 2022, a total of 425 e-mulakats were held between the inmates and their relatives.

Regarding the shifting of the office of J&K LSA to some appropriate place, it was resolved that as and

when the office of the Transport Commissioner is vacated after shifting to the new building, the Estates Department shall initiate the process of allotment of the said office space for the office of J&K LSA.
