02. Whereas, the qualification prescribed for the post of Motor Vehicle Traffic Assistant as per Indent is given as under:

"a) Minimum Qualification 10th with ITI Motor Mechanic Vehicle of two years Course from any recognized Institute.

b. Having Driving License of Motor Cycle with Gear and Light Motor Vehicle".

03. Whereas, the Jammu & Kashmir Services Selection Board, vide Notification No. 04 of 2020 dated 16.12.2020, advertised these posts as per the category-wise break-up given hereunder for seeking applications from the eligible candidates; and

04. Whereas, the Jammu & Kashmir Services Selection Board conducted the Computer Based Test (CBT) for selection of candidates to the aforementioned advertised posts as per Notice No. SSB/COE/2021/7084-92 dated 16.10.2021 in multiple shifts/sessions on 02.11.2021; and

05. Whereas, based on the performance of the candidates in the aforesaid Computer Based Test (CBT), the J&K Services Selection Board, vide Notification No. SSB/COE/CBT/2022/2718-24 dated 15.03.2022, published the result/score sheet of the candidates; and

06. Whereas, after publication of result/score sheet, the candidates falling in the zone of consideration, were called for Document Verification vide Notification No. SSB/Secy/2022/4388-94 dated 19.05.2022, followed by supplementary Document Verification vide this office Notification No. SSB/Secy/2022/4585-90 dated 30.05.2022; and

07. Whereas, in order to avoid repetition of candidates in the Selection Lists, the Board, after due consideration, sought preferences vide Notification No. SSB/ COE/ CBT/ 2022/4597-4603 dated 30.05.2022 for these items from the candidates figuring in the zone of consideration; and

08. Whereas, with the approval of the Board, the Provisional Selection Lists for these posts were notified on 01.07.2022 vide Notification No.SSB/Secy/Sel/2022/5074-83 dated 01.07.2022 and objections were sought from the candidates within a period of 05 days from the date of issuance of the Provisional Selection lists; and

09. Whereas, soon upon the Notification of the Provisional Selection Lists on 01.07.2022, where-under, among others, two posts belonging to the Scheduled Tribe (ST) were kept unfilled for want of eligible candidates, it was observed that due to some typographical error, the data in respect of ST candidates was not fetched and therefore, such candidates, even-while figuring in the merit list, were not called for the Document Verification. Accordingly, vide Notification No.SSB/Secy/2022/5229-35 dated 13.07.2022, all the ST candidates figuring in the zone of consideration were called for the DV.

10. Whereas, the Board received representations/objectionsagainst theProvisional Selection Lists, which were examined by the Selection Committee andafter considering all relevant aspects including issues relating to qualificationprescribed in terms of applicable rules, recommended appropriate disposal of the representations/objections so received, for consideration and approval of the Board; and

11. Whereas, the Selection Committee, in accordance withapplicable rules,having regard to category wise break-up of posts advertised, prepared the Final Selection Lists in respect of the aforementioned posts for consideration and approval of Board; and

12. Whereas, the Board in its 207th Meeting held on 29.07.2022, after detailed deliberations, approved the aforesaid Selection Lists prepared by theSelection Committee.

13. Now, therefore, in view of the above:

- The Final Selection Lists, along with the Waiting Lists of the candidates for the post of 'Motor Vehicle Traffic Assistant' (Transport Department), advertised vide Notification No.04 of 2020 dated 16.12.2020 for UT/Div.
