said that huge investments are being made in Jammu and Kashmir. There are proposals of Rs 56,000 crore investments and Prime Minister Narendra Modi had kick started the schemes in a Jammu village on April 24 this year. Dubai companies are investing. Rapid development work is going on and the projects involving around Rs 38,000 crore investments are currently underway. On other fronts, he said the number of flights from Srinagar Airport has increased from 33-32 daily to 110 and 6 from Jammu Airport to 44. He said the road network has got a special impetus. Good roads are being laid. The Jammu-Srinagar journey being undertaken in 11 hours earlier is now possible in five and half hours. He said the day is not far when the distance will be covered in four and half hours.

We are trying to increase tourism; the Lieutenant Governor said adding that the government is endeavouring to bring some tourist destinations, hitherto unexplored, on the tourism map of Jammu and Kashmir. "Some places are known to the country and the world. Although some places are not known to the people of the country and the world, we are working for this", he said.

Sinha countered the question about the role of the bureaucracy, asserting that it the bureaucracy) is not a hindrance in the holistic development work

When asked about some opposition leaders having been put under house arrest, Sinha quipped, "Not a single political worker is under house arrest".

Regarding terrorism in the Valley, the Lieutenant Governor said there has been a decline in terrorist incidents. The security forces have edge over terrorists. Terror is being effectively tackled. He said that in the past three years, not a single innocent person has been killed by the Army, Police or the Security Forces' bullets. He said that narco terrorism is emerging as a big challenge and the neighbouring country is pushing youth to wall. He said several initiatives are being taken to keep the youth away from terror and drug addiction. In this context, he referred to the rehabilitation programmes being undertaken by the Social Welfare Department.

"We have clearly said that do not touch the innocent and do not spare the guilty-Be-Gunah Ko Chero Mat Aur Gunahgar Ko Chorro Mat". He said that Jammu and Kashmir is witnessing an era of peace and prosperity. Today the government is establishing peace, earlier the peace used to be bought, he said, adding that his administration has been very successful in winning the trust of the people

The Lieutenant Governor said the government is on the way to fulfill the policy of settlement of Kashmiri Pandits in Kashmir in terms of housing and employment for them. As part of rehabilitation, 6000 posts and 6000 flats have to be put in place. While 3000 posts had been filled up, the process for filling up the remaining vacancies is gaining momentum. He said 1200 flats will be ready by October this year and within a year and half the target of accommodation is likely to be completed fully. He also referred to the launch of a portal for registering complaints by the Kashmiri Migrants-Hindus, Muslims and Sikhs-and said that 6,000 of the 8,000 complaints have been disposed of while 2,400 kanals of land has been retrieved.

Sinha said the people of Kashmir strongly believe that Kashmir is incomplete without Kashmiri Pandits. He said Sufism is the ethos of the land of Rishis and saints and hoped that this great tradition will restore the pristine glory of the Valley. He also referred to the spiritual ethos of Lala Ded.

When asked about the response to the Ghar Ghar Tiranga Campaign in Jammu and Kashmir, Sinha said that the people are enthused. He made an appeal to the people to make the campaign a success

In a round of rapid-fire questions, Manoj Sinha said that he puts all of his capabilities and mind for the people here and that likes his gubernatorial assignment in Jammu and Kashmir.

NEW DELHI: India on Friday hit out at the Organisation of Islamic Cooperation (OIC) for its latest statement on Jammu and Kashmir and said it "reeks of bigotry"

"The statement issued by the General Secretariat of the Organisation of Islamic Cooperation (OIC) on Jammu and Kashmir today reeks of bigotry," Bagchi

said. He asserted that the Union Territory of Jammu and Kashmir "is and will remain an integral and inalienable" part of India. "As a result of long-awaited changes three years ago, it today reaps the benefits of socio-economic growth and development," Bagchi said.

OIC "The General Secretariat, however, continues to issue statements on Jammu and Kashmir at the behest of a serial viola-

tor of human rights and notorious promoter of cross-border, regional and

international terrorism," he said in a clear reference to Pakistan.

"Such statements only expose the OIC as an organization devoted to a communal agenda being pursued through terrorism." he added.

Pakistan has been making concerted efforts to internationalise the Kashmir issue.

The neighbouring country stepped up an anti-India campaign after New Delhi announced in on August 5, 2019, its decision to withdraw the special powers of Jammu and Kashmir and bifurcate the state into two union territories.

Police dismisses claim about house-arrest of Farooq Abdullah

"There is fake news going that some NC and PDP leaders have been placed under house arrest in Gupkar Road. This news is completely baseless," a police spokesman said.

He was reacting to claims of the National

Conference, including its vice president Omar Abdullah, that Farooq Abdullah, the Lok Sabha member from Srinagar, had been placed under house arrest

"It seems they have to place this truck outside the gate out of some compulsion because it's a senseless act (aside from being totally illegal). He went to the office, went for Namaz, went for a condolence visit. The truck arrived after he had nowhere else to go today. Fools!!" Omar Abdullah tweeted.

The NC spokesman had tweeted about the

house arrest of the former J and K chief minister. "Dr Farooq Abdullah has been placed under house arrest after returning from Nawai-Subha where he had earlier presided over a meeting and said 'We will peacefully fight for our RIGHTS that were illegally, unconstitutionally and undemocratically snatched from us on August 5, 2019'." he said.

However, the police spokesman said additional security personnel were deployed at certain places on Gupkar Road in view of "certain inputs of a terror attack".

"Ms Mehbooba Mufti visited her party headquarters around noon time and Dr Farooq Abdullah visited Hazratbal shrine and his friend in Shalimar in the afternoon. Media friends are advised to verify news from authorities before circulating (them). JKP is a fully professional police force and is well aware of its duties," he said

The police spokesman also posted the latest photographs from outside the residences of Abdullah and Mufti which showed no presence of security vehicles.
