Whereas, you have been appointed in the State Motor Garages Department as Chowkidar on Compassionate grounds under SRO-43 of 1994 vide Government Order No. 18-TR of 2015 dated: 04-03-2015 and joined in the this Office, at Jammu on 06-03-2015; and

Whereas, vide Director, State Motor Garages Department, J&K Order No. 479-DSMG of 2016 dated 08-11-2016, you were posted in the Regional Office, SMG, Jammu for further duties and subsequently included in the Darbar Move Winter Session 2016-17 vide Director, State Motor Garages Order No. 515/DSMG of 2016 dated 28-11-2016; and

Whereas vide Director, State Motor Garages Department J&K Srinagar order No. 223-DSMG of 2017 dated 15-05-2017, you were transferred to Regional office SMG Jammu for further duties; and

Whereas, you joined Regional Office, SMG Jammu on **01-05-2017** and remained present up to 17-05-2017 and from **18-05-2017 to 21-05-2017**, you remained **un-authorized absent** from duties for a period of **04 days** without any reasonable explanation; and

Whereas, you applied for 30 days **Earned leave w.e.f 22.05.2017 to 21.06.2017** for self treatment which was sanctioned by the Deputy Director SMG Jammu vide order No. 72 of 2017 dated 30.05.2017; and

Whereas, you **extended 30 days Earned leave w.e.f 22.06.2017 to 21.07.2017** which was sanctioned vide order No. 91 of 2017 dated 18.07.2017 by the Deputy Director SMG Jammu; and

Whereas, you again applied for extension of your earned leave for a period of 46 days w.e.f 22.07.2017 to 05.09.2017 which was not accepted by the competent authority as no leave was due in your leave account at that time and you remained **un-authorized absent** from duties w.e.f **22-07-2017 to 12.10.2017** for a period of **83 days** without any reasonable explanation; and

Whereas, you had submitted leave application form for 30 days commuted leave w.e.f **13.10.2017 to 12.11.2017** which was not sanctioned by the competent authority and you were asked to apply for commuted leave in the prescribed Form-3 and Form-4 duly recommended by Authorized Medical Authority which you failed to submit and no leave was sanctioned in your favour and you remained **un-authorized absent** from duties at your own w.e.f **13.10.2017 to 15.11.2017**; and

Whereas, you reported for duties on **16.11.2017** and remained present w.e.f **16.11.2017 to 26.02.2018** except 05.01.2018, 06.01.2018 and 21.02.2018 without any leave or prior permission; and

Whereas, you again remained **un-authorized absent** from duties at your own w.e.f **27.02.2018 to 27.03.2018** for a period of **29 days**; and

Whereas, you again submitted commuted leave form for **23 days w.e.f 28.03.2018 to 19.04.2018** which was supported by the Medical Certificate issued by Dr. Mohinder Sandhu on his letter head and the same was not accepted by the Competent Authority and you were again directed to apply Medical leave on prescribed Form-3 and Form-4 under Rule 19 and 24 of Civil Services Leave Rules, 1979, which you failed to submit and your commuted leave was not sanctioned; and

Whereas, you remained **un-authorized absent** from duties w.e.f **28.03.2018 to 31.05.2018** for a period of **62 days**; and

Whereas, you resumed your duties w.e.f **01.06.2018 to 03.08.2018** and remained **un-authorized absent** from your duties w.e.f **04.08.2018**; and

Whereas, while taking cognizance of continued un-authorized absence and conscious negligence of duties on your part, you were placed under suspension by the Deputy Director, SMG, Jammu vide order No.94 of 2018 dated 27.08.2018 and even after suspension, you remained un-authorized absent from duties; and

Whereas, a charge sheet was served upon you by the Deputy Director, SMG, Jammu vide No. PF-1075/SMGJ/4495-98 dated 17.09.2018 wherein you were given an opportunity to explain your position for remaining continuously **un-authorized absent** from duties w.e.f **04.08.2018 to 07.04.2019** for a period of **246 days** and you were directed to resume your duties but you neither replied to the charge sheet nor resumed your duties; and

Whereas, you alongwith your family members approached Deputy Director, SMG, Jammu and pleaded that you were ill and was not in a position to attend duties and assured that you will remain punctual in future; and

Whereas, taking a lenient view on medical and humanitarian grounds, you were given an opportunity to overcome the above shortcomings and you were re-instated by the Deputy Director, SMG, Jammu vide Order No. 48 of 2019 dated 08-04-2019 with the remarks that the period of your un-authorized absence shall be decided later on;

Whereas, after your re-instatement, you again remained un-authorized absent from duties w.e.f 08/04/2019. The way of your working and to remain un-authorized absent from duty proves that you are habitual of not attending office regularly which created gross indiscipline in the Department; and

Whereas, a Notice served to you by the Deputy Director, SMG, Jammu for your **un-authorized absence** from duties w.e.f **08.04.2019 to 01.12.2020** for a period of **603 days** vide No. Estb/SMGJ/3428-29 dated 01.12.2020, mentioning therein that date wise periods of your un-authorized absence and you were given an opportunity to explain in writing as to why appropriate disciplinary action under Article-128 of JK CSR should not be taken against you; and

Whereas, you did not pay any heed to the aforesaid notice and remained continuously **un-authorized absent** from duties w.e.f **02.12.2020 to 22.02.2021** for a period of **83 days again**; and

Whereas, instead of responding to the Notice served upon you, you submitted leave application form on **23-02-2021 for 90 days Extra Ordinary Leave w.e.f 23-02-2021** on the grounds of medical treatment which was not sanctioned by the competent authority in view of your continuous un-authorized absence; and

Whereas, you remained **un-authorized absent** from duties w.e.f **23.02.2021 to 04.03.2021 for a period of 41 days again** at your own level; and

Whereas, on **26-07-2021** you submitted a written reply to the Deputy Director SMG Jammu in pursuance to the Notice served to you vide No. Estb/SMGJ/3428-29 dated 01-12-2020 but the same was found un-justified and was not accepted by the Administration.

Whereas, Section officer (Tpt), SMG Jammu reported that you remained present w.e.f **05.03.2021 to 06.08.2021** and again remained **un-authorized absent** from duties w.e.f **07.08.2021** without any leave application or any intimation to the competent authority and is **absconding since then**; and

Whereas, Deputy Director SMG No. Estb /SMGJ/3972-73 dated 25.11.2021, gave you last opportunity to explain your position with regard to your un-authorized absence and you were directed to submit the reply within ten days positively, but no response has been received from your side till date; and

Whereas, the Show Cause Notice was sent to you on your residential address viz; *Iqbal Colony, Sidhra Jammu Pin Code No. 180019* vide No.MF-1075/1768-71/DSMG dated 30-06-2022 through Speed Post but the postman, Post Office Jammu has returned the Show Cause Notice to this Department and intimated that you was not present at home and your family members opened the envelopment, read it and refused to receive the said notice with the reasons best known to them; and

Whereas, you have been given ample opportunities to overcome from such shortcomings but you had taken all the warnings casually and has not shown any improvement which clearly indicates that you are not interested to serve in the department; and

Whereas, the un-authorized absence from duty regularly for months together is a serious misconduct on your part and invites strict disciplinary action against you under Article-128 JK CSR 1956.

Now, through the medium of this notice you are directed to resume your duties forthwith and show cause in writing within 10 days positively as to why major penalty proceedings should not be initiated against you as per the provisions of Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules 1956 read with Article 128 of Jammu and Kashmir Civil Services Regulations 1956, failing which it shall be presumed that you have nothing to say in your defense and further course of action as warranted under rules shall be initiated against you without any further notice.
