- Whereas, you were supposed to report at APHQ J&K on 01.01.2020 after availing journey time, but you did not report at APHQ J&K till 31.03.2021.
- Whereas, further you were formally adjusted in this unit (IRP-14th Bn) vide APHQ J&K order No.243 of 2021 dated 31.03.2021, but till date you have not reported/joined in this unit and still absconding from legitimate duties.
