- Minimum qualification shall be 10+2 and maximum graduation. In case no 10+2 pass candidate is available in the ward, 10+2 pass candidate from the adjoining ward shall be considered which would require prior approval of Mission Director, Mission Poshan.
- In case suitable candidate is not available from the adjoining ward, candidate from nearest ward within the Panchayat can be considered subject to the approval of Mission Director, Mission Poshan
- Weightage shall be given on the basis of marks obtained in 10+2 and selection shall be done purely on merit basis and no other criteria to be considered.
- In case of eligible candidate is available within the family of retiring Anganwadi Worker/Anganwadi Helper, the said candidate shall qualify for additional two percent points.
- In case of tie in merit of the eligible candidate, candidate with the higher age will be preferred.
