"If there are any discrepancies in the functioning of the smart meters, the concerned department must be held accountable," Wanehoo said. In addition, the Wanehoo has called upon the administration to embark on a comprehensive awareness campaign to educate the residents of Jammu and Kashmir about the implications of smart meters.
