**Inter-state heroin smuggler arrested with 200 gm heroin**

**SAMBA:** Police on Friday arrested an interstate heroin smuggler and recovering 200 grams of heroin from his possession.

The arrested interstate heroin smuggler has been identified as **Yaqoob Ali** alias Yuqo, son of Sain, resident of Shahjapur Tehsil Ramgarh district Samba. FIR No.108/2023 under section 8/21/22/29 NDPS Act has been registered at Police Station Vijaypur and investigation is underway.



The interstate heroin smuggler has been arrested by the District NDPS Team and Police Station team at a special naka at Swankha Morh in the jurisdiction of Police Station Vijaypur.

**CB charge-sheets fraudster for impersonating as Deputy Secretary Civil Secretariat**

**JAMMU:** Economic Offences Wing - Crime Branch Jammu Charge sheets accused **Ashiq Hussain**, son of Ghulam Hussain, resident of Village Barthi Tehsil Gandoh District Doda in FIR No. 64/ 2022 under section 420, 170/IPC Police Station Crime Branch Jammu, after allegations of cheating and duping the unemployed youth of his hard earned money on the pretext of arranging him job as Probationary Officer in J&K Bank were substantiated during the course of Investigation conducted by the premier Investigating Agency of the UT of J&K in the instant case. The fraudster lured the complainant among other unemployed youth by impersonating as Deputy Secretary in the Civil Secretariat, who actually happens to be a class-IV employee in PDD Special Division, Gandoh.



The case owes its origin to a complaint received through the Lt. Governor's Grievance Cell, wherein complainant **Raghubir Singh Chib**, son of Late Bansi Ram, resident of Village Natar Kothan Tehsil Jammu District Jammu alleging therein that he was cheated and defrauded by the accused who induced him on the pretext of arranging job of Probationary Officer in the J&K Bank in lieu of Rs 6 Lakhs. On this criminal proceedings were initiated against the accused with the approval of Crime Headquarters in the form of preliminary verification. During probe the allegations were prima facie substantiated and the instant case was registered under the relevant sections of law for in-depth investigation. During investigation documentary/oral evidence was collected, besides circumstantial evidences enumerated during the course of investigation the offences under section 420,170/IPC have been established.

**7 drug peddlers arrested, contraband recovered**

**SRINAGAR:** Continuing its efforts to eradicate the menace of drugs from the soci-

ety, police on Friday arrested 07 drug peddlers in Sopore, Kulgam, Budgam & Baramulla and recovered contraband/ psychotropic substances from their possession.

In Sopore, a police party at a checkpoint established at Hib Dangerpora intercepted & apprehended a notorious drug peddler identified as **Fayaz Ahmad Wani** son of Muhammad Abdullah Wani resident of **Tujjar Shareef** Sopore. During checking, 12 bottles of Codeine phosphate were recovered from his possession. He has been arrested and shifted to police station where he remains in custody.

In Kulgam, a police party of Police Station Qazigund at a checkpoint established at Drien Daulatabad near NHW intercepted & apprehended a notorious drug peddler identified as **Suhail Ahmad Ganie** son of **Bashir Ahmad Ganie** resident of **Brankher Drien, Daulatabad**. During search, 5Kgs of poppy straw like contraband substance from his possession. He has been arrested and shifted to police station where he remains in custody.

In Budgam, a police party of Police station Magam arrested 04 drug peddlers identified as **Zahid Majeed Bhat** son of **Abdul Majeed Bhat, Irfan Ahmad War** son of **Abdul Ahad War** both residents of **Peth-Kanihama, Tariq Ahmad Parray** son of **Ghulam Mohammad Parray** resident of **Warihama** and **Fayaz Ahmad Dar** son of **Abdul Rahman Dar** resident of **Badran Magam**. During search, 40 bottles of codeine phosphate and cash amount of Rs. 13100/= was recovered from their possession. They have been arrested and shifted to police station where they remain in custody. More recoveries and arrests are expected in the said case.

In Baramulla, a police party under the supervision of SDPO **Pattan Shri Mohd Nawaz-JKPS**, assisted by Incharge PP **Pallhallan** arrested a drug smuggler named **Abdul Hameed Mir** son of **Ghulam Hassan Mir** resident of **Seru Gudwani Pattan** during checkpoint at **TCP Palpora Crossing Pattan**. During search, 2,750 Kgs of Poppy Straw like contraband substance concealed in a bag was recovered from his possession. He has been arrested and shifted to police station where he remains in custody.

Accordingly, cases under relevant sections of law have been registered at respective police stations and further investigation have been initiated.

**13 vehicles seized, 13 arrested for Illegal extraction & transportation of minerals**

Similarly, a police team led by SHO **Kunzer** seized 02 tippers and arrested 2 drivers namely **Gh Qadir Khan** son of **Ab Rehman** resident of **Mangloora & Mohd Arif Shah** son of **Nazir Ahmad** resident of **Takiya Batpora** at **Ferozpora Nallah Kunzer** who was found involved in illegal extraction & transportation of minerals

**Police busts deceptive jeweller in counterfeit gold ornament scam; accused arrested**

**PULWAMA:** In a significant breakthrough against fraudulent activities, Police in

Pulwama on Friday arrested a deceptive jeweller in counterfeit gold ornament scam.

Police in Pulwama received a series of complaints against the jeweller named **Sajad Ah Zargar**, (operating a gold shop named **Diamond Jewellers** at **AL-Ahmad** complex near **Shaheed Farooq Chowk Pulwama**), allegedly deceived customers with counterfeit gold ornaments and has been engaging in this fraudulent activity for an extended period. Acting swiftly, the accused jeweller involved in the commission of crime was arrested and shifted to police station where he remains in custody. Accordingly, a case FIR No. 210/2023 was registered at Police Station Pulwama, and a thorough investigation has been initiated.

The arrest follows a meticulous investigation into allegations of counterfeit gold ornaments being sold to innocent customers, shedding light on a series of complaints against the accused. This apprehension serves as a stern warning to those involved in fraudulent practices, as J&K Police remains vigilant in ensuring the safety and well-being of the community.

**Excise Deptt destroys 450kg Lahan, one ltrs illicit liquor**

**Narco smuggler nabbed with 10 grams heroin**

**4 vehicles involved in illegal mining seized**
