Whereas, the General Administration Department, vide Communication No. GAD-SERV0KAS/575/2021-02-GAD dated 18.04.2022, referred 220 posts to the J&K Public Service Commission for being filled up through the Combined Competitive Examination; **and,**

Whereas, these posts were advertised by the Commission vide Notification No. 08-PSC(DR-P) of 2022 dated:19.04.2022; **and,**

Whereas, 34,121 candidates were provisionally admitted for the Preliminary Examination. Besides, 03 candidates were allowed to appear on the directions of Hon'ble Central Administrative Tribunal in O.A No. 527/2022 and 520/2022; **and,**

Whereas, Preliminary Examination was conducted on 31.07.2022, in which 23,571 candidates appeared in the Examination; **and,**

Whereas, as per the criteria fixed by the Commission, vide Notification No. PSC/Exam/2022/22 dated: 17.08.2022, a total of 4944 candidates were declared to have qualified for the Mains Examination; **and,**

Whereas, J&K Combined Competitive (Mains) Examination, 2022, was conducted from 20.02.2023 to 02.03.2023, both at Jammu and Srinagar in which 3891 candidates appeared in all papers; **and,**

Whereas, as per the criteria fixed by the Commission in accordance with SRO 103 of 2018 dated 23.02.2018, as amended from time to time, in pursuance of Decision No. 18.3 of 18th Meeting of the Commission held on 22.06.2023, 787 candidates were declared to have qualified for interview vide Notification No. PSC/Exam(s)/2923/25 dated 22.06.2023; **and,**

Whereas, the Personality test (interview) of these candidates was conducted w.e.f 10.07.2023 to 22.08.2023 at the Srinagar Office of the J&K PSC; **and,**

Whereas, 05 candidates did not appear in the interview; **and,**

Whereas, the Commission in its Extra Ordinary Meeting held today on 22.08.2023 decided to declare the result of the candidates who appeared in the interview and also notify their aggregate marks while publishing a list of candidates to be summoned for Medical Examination in accordance with the relevant rules.

Now, therefore, in pursuance of the provisions contained in SRO 103 of 2018 dated 23.02.2018, read with J&K Public Service Commission (Conduct of Examination) Rules 2022 as well as the above-mentioned decision taken by the Commission, it is hereby ordered to:

- Declare the result of 772 candidates out of the 782 candidates who appeared in the interview of Jammu and Kashmir Combined Competitive Examination 2022, as per Annexure-I to this Notification.
- Withhold the result of 10 candidates who require further clarification with regard to their eligibility.
- Direct 218 candidates as per Annexure-II of this notification, by order of their aggregate merit, read with J&K Reservation Rules (SRO 294) as amended up-to-date, to report for Medical Examination before the respective Medical Boards constituted/or to be constituted in GMC- Anantnag, Baramulla, Doda, Handwara, Jammu, Kathua, Rajouri, Srinagar and Udhampur, whichever Board the candidate may choose, for conduct of their Medical Examination as per proforma, in accordance with rules on the subject. The medical Examination will take place on 23rd and 24th of August.
- Delete the name of Ms. Shalinin Chandel recommended against a Jr. Scale Post under CCE, 2021 vide letter No. PSC/Exam/CCE(M)/2021/46 dated 08.08.2023, from the select list.

The candidates recommended for medical examination will have to pay a fee, as prescribed, before Medical check-up.

- Mere calling a candidate for Medical Examination shall not confer any right on him/her to be recommended for selection.
 - Detailed marks cards shall be available on the website of the Commission after completion of the examination process and after forwarding the select list to the Government for making appointments.
 - The lists notified as Annexure-I & II to this notification are provisional and subject to the outcome of the writ petition(s), if any, pending before any Competent Court of jurisdiction.
