# Ex-VC SKUAST, others discharged in case registered by ACB

# DB grants special exception for maintenance, repair work by Army

**STATE TIMES NEWS** JAMMU: A Division Bench of Jammu & Kashmir and Ladakh High Court comprising Chief Justice N Kotishwar Singh and Justice M. A Chowdharv has allowed the Indian Army to conduct vital maintenance and repair works in existing structures within the High Altitude Warfare School (HAWS) and other transit camps situated in the pristine region of Sonamarg

Marking a distinct departure from previous restraints imposed by the court, the Division Bench highlighted the exceptional nature of the Army's role in safeguarding the Nation.

"Considering that carrying out the said maintenance/repair works are urgently required and the fact that this pertains to security of the Nation which is of paramount importance, and thus cannot be equated with other commercial enterprises engaged in profit

making activities, and the army/security forces can be treated to be a class by itself distinguishable from other commercial enterprises, we are of the view that an exception can be made to the restraint orders passed by this Court and the application should be allowed to out maintenance/repairing works as mentioned in the report" it observed.

The directions were passed in response to an application Tahir Shamsi DGSI, seeking permission from the Court in the backdrop of blanket ban on any construction activities in Sonamarg.

The Court had few years back undertaken this matter a Public Interest Litigation, responding to reports of unauthorized constructions in the Sonamarg area. Over time, the court's orders have regulated constructions in the area, keeping in view the several associated environmental concerns. It was in the said pursuit that the court had issued a blanket ban on carrying out construction activities within the peripheries of this famous tourist destination.

Acknowledging the constrained time window and the pivotal role of these installations in supporting the Army's counter-insuroperations defense strategies, the bench observed.

"Under the circumstances. we hold that the bar placed by this Court should not come in the way of Building Operations and Controlling Authority to consider and give permission to the army authorities to undertake maintenance/repair work as sought by them,' Court said and directed the Building Operations and Controlling Authority to grant permission to the army authorities for the execution of necessary maintenance and repair works.

m the}$ then tion, Chancellor , SKUAST Jammu appointed Sanjay Sharma as PRO (Public Relations Officer ) in violation of all norms and rules without publishing the advertisement in the leading newspapers.

During the course of verification, it emerged that Sanjay Sharma was initially engaged as Computer Programmer in SKUAST Jammu on adhoc basis in the year 2000 and then as PRO to Vice Chancellor on problem basis and was confirmed in the year 2000. In order to bestow illegal benefit upon Saniay Sharma A1, the officials of SKUAST twisted and distorted the rules and without competence and power, created a non - existent post of Deputy Registrar Secrecy. As per the alleged charges against the accused persons a criminal Conspiracy was hatched between Sanjay Sharma, Vice Chancellor SKUAST and then Assistant Registrar SKUAST A.K.Koul

Moreover, the allegation leveled was that there was no proposal or sanction of competent authority thereby indicating that the appointment was illegal.

After hearing arguments of prosecution Advocate S.K. Bhat for Accused Hashmatullah khan Vice Chancellor SKUAST, Nagendra Sharma and Vijay Soi along with the other Counsels for the rest of the accused, the court observed, "the perusal of charge-sheet and material collected during investigation reveals that there are absolutely no grounds for presuming not to speak of even suspicion about the accused having committed offence under

Prevention of Corruption

Act". Moreover, the Court also made it clear that the principal issue before the Court is whether the charge sheet filed by the investigating officer is in accordance with the provisions of the Cr.pc as laid down under sec 173 (8).

It is pertinent to mention

that the investigating officer was directed by the Court to further investigate the matter and the I.O had observed earlier that the allegations leveled have not been substantiated within the view of P.C.Act as such the investigation of the case be closed as not proved. The I.O did not come across with any fresh evidence during further investigation as such no prima facie case could be established against the accused persons. Therefore, the Court observed that neither the further investigation is proper and in accordance with law nor the charge sheet is sustainable in

the eyes of law. So far as the appointment of Sanjay Sharma is concerned, it was not established by the prosecution that it was an illegal appointment and there was no allegation that he had produced a fake certificate at the time of his adhoc appointment. Further the Court opined that in the entire Charge sheet, there are no allegations of any kind, whatsoever, of any demand, acceptance or giving of any bribe by anybody to anyone. Accordingly there seems no

legal bias in the appointment of the said accused Sanjay Sharma to the post of PRO beyond the powers and competence of the Vice Chancellor and the other accused involved therein as such no criminal conspiracy can be attributed to all the accused persons in the alleged commission of the offenses by ACB, the court said, adding "accordingly, accused present in the court are discharged and challan is dismissed".
