

Govt holds Controller LMD responsible for delay in settlement of audit objections

JAMMU: The Jammu and Kashmir government on Saturday held Controller Legal Metrology Department (LMD) responsible for delay in submission of replies for settlement of the outstanding audit paras as desired by the office of Principal Accountant General (Audit).
In its explanatory letter, Department of Food, Civil Supplies & Consumer Affairs, Civil Secretariat Jammu in its letter FCSCA-Acts/26/2023 (e-7251206 dated August 4, 2023 has observed that while Director General, Accounts & Treasuries vide O.M No. DGAT/Audit/PS/243 dated July 21, 2023 has directed to ensure timely submission of replies for settlement of the outstanding audit paras as desired by the office of Principal Accountant General (Audit) vide communication No. DAG/Seectt(J/2023-24/102 dated July 20, 2023 and where under Principal AG has devised phased manner strategy for time bound settlement of audit paras of 13 department sin first phase including Legal Metrology Department having 19 outstanding audit paras after settling down 38 audit paras after March, 2023 by the continuous efforts of administrative department and same was forwarded to the concerned department vide No.FCSCA-Acts/16/2023 (e-7181101) dated July 21, 2023.
The communication further

reads that in wake of this important issue, Principal Secretary, Finance Department took a meeting on July 25, 2023 and directed all the Directors of Finance to make all out efforts to ensure replies for settlement of audit paras within a week's time in respect of all the 13 departments.
It further wrote that in view of the short span of time given by the authorities for completing the whole activity, the Controller, Legal Metrology Department, J&K was contacted telephonically repeatedly for coordination required, for smooth submission of replies and thereby settlement of all outstanding audit paras but he didn't respond to such an urgent issue due to which administrative department contacted subordinate officials for nominating/deputing any suitable official for close coordination between administrative department and office of the Principal Accountant General, J&K.
The subordinate officials of the Legal Metrology Department nominated Rakesh Kumar, MTS working in the office of Assistant Controller, Legal Metrology Rajouri for sending requisition for deputation of Rakesh Kumar, (MTS) and therefore Administrative Department made requisition under intimation to controller Legal

Metrology Department, J&K, along with Principal Secretary Finance Department and Commissioner/Secretary FCS&CA Department vide communication No.FCSCA-Acts/16/2023 (e-7181101) dated July, 2023 and thereafter Assistant Controller, Legal Metrology Department, Rajouri vide Order No.LM/ACR/81-83/2023-24 dated July 24, 2023 deputed Rakesh Kumar, MTS, for a period of one week, to file report in three days.,
In the aftermath of submission of replies for settlement of audit paras, the Controller tried to distract and choke down the collaborated whole hearted efforts of Finance Department, Administrative Department and Principal Accountant General, J&K, for settlement of all outstanding audit paras in phased manner. This led to wastage of crucial 4 days out of 7 days given by the authorities for this important assignment. After realising the grave situation for time bound completion of assignment deputed, other official Satish Kumar Sharma was deputed.
This office left no stone unturned to even waste the remaining 3 days out of 7 days given by authorities for completion of assignment by calling explanation of Director Finance, FCS&CA Department for this act of ensuring submission of replies to the office of the

Accountant General J&K.

The circumstances/situation created by the Controller, the Administrative Department could ensure the submission of replies of all 19 outstanding audit paras to AG Office despite all hindrances.
Lack of proper coordination by the Controller, the head of Legal Metrology Department, J&K and even till today not responding to phone calls of Administrative Department, the discussions to be held for settlement of outstanding audit paras in respect of Legal Metrology Department seems to be remain unfruitful.

The un-supportive attitude of Controller as usual not only created obstacles in performing legitimate duties of the Adm. Department but it also transpires that he had made every possible effort to choke down the collaborated whole hearted efforts of whole Finance Department, Administrative Department and Principal Accountant General, J&K, for settlement of all outstanding audit paras in phased manner.
"In view of the above facts and circumstances, the Controiller was asked that if any of the outstanding paras may remain unsettled and reflected in the PAC report, it shall be his sole responsibility being the head of Legal Metrology Department, J&K.
