CRIME REPORT

Drug smuggler arrested, contraband substance recovered Wild Cannabis destroyed in Magraypora

BARAMULLA: Continuing its efforts to eradicate the menace of drugs from the society, police have arrested a drug smuggler in Baramulla and recovered contraband substance from his possession. Besides, destroyed wild Cannabis at Malik Mohalla Magraypora Baramulla.

A police party led by SHO Uri at a checkpoint established at Paranpeelan Uri intercepted a suspicious person who tried to flee from the spot but was apprehended tactfully by the alert police party. During search, 9 grams of Heroin like contraband substance concealed in a bag was recovered from his possession. He has been identified as Yasir Ahmad Khan son of Shakeel Ahmad Khan resident of Paranpeelan Uri. He has been arrested and shifted to police station where he remains in custody. Accordingly, a case under relevant sections of law has been registered at Police Station Uri and investigation has been initiated.

Moreover, Police received information regarding the presence of wild cannabis at Malik Mohalla Magraypora Baramulla. Accordingly, a police party led by Incharge Police Post Wussan alongwith Sarpanch, Numberdar & respectables of Magraypora Wussan under the overall supervision of SDPO Pattan Shri Mohd Navaz-JKPS, reached the spot and destroyed the wild cannabis spread over 5 kanals of land. General public of these areas have hailed the efforts of the Police.

4 missing persons traced, reunited with families

Machinery of NHAI contractor seized for illegal mining near bridge

KATHUA: A heavy excavator and dumper of NHAI contractor involved in illegal extraction near national highway bridge over Sahar Khad seized in Kathua here today. The action was initiated by District Mineral Officer (DMO) Kathua Rajinder Singh Rana who along with mineral guards was on his routine visit in Sahar Khad and adjoining areas to check the illegal mining activities. Deputy Commissioner Kathua Rakesh Minhas was immediately apprised about the incident who further instructed DMO to immediately stop the excavation work and seize the Machinery involved in illegal mining.

Reportedly, the excavator had excavated a total of 500 MT of minor mineral from the Khad and as per the rules of the Geology and mining department, around 2 lakhs penalty shall be imposed on the machinery engaged for illegal and unauthorized mining.

The seized excavator and dumpers handed over to police party sent by police station Kathua on the direction of Senior Superintendent of Police Kathua Shivdeep Singh Jamwal.
