
# SHRADHANJALI



Collaborating seamlessly with the local police department and the Geology & Mining department, the operation yielded substantial results, as two trolleys loaded with illicit minerals were seized in Gandoh.

## 2 drug peddlers arrested; contraband recovered

**GANDERBAL:** Continuing its efforts to eradicate the menace of drugs from the society, Police in Ganderbal have arrested 02 drug peddlers and recovered contraband substances from their possession.

As per details, a party of Police Station Ganderbal at a checkpoint established at Saloora, arrested a notorious drug peddler identified as Waseem Ahmad Bhat alias Kulcha son of Gh Mohammad Bhat resident of Wanipora Saloora. During search, 33 strips of banned drugs (Doltemm-100) were recovered from his possession.

Similarly, a Police party of PS Sonamarg at a checkpoint established at Naka Shuktadi, intercepted a vehicle (Alto-800) bearing registration number JK04E-9332 driven by Manzoor Ahmad Reshi son of Ab Rehman Reshi resident of Haripora Bonzail Kangan. During search, poppy straw was recovered from his possession. He has been arrested and the vehicle used in the commission of crime has also been seized.

Accordingly, cases under relevant sections of law have been registered at respective police stations and investigations have been initiated.

## Missing lady-son duo traced

**JAMMU:** Miran Sahib Police on Monday traced a missing woman and her son.

As per official sources, on August 3 this year, missing report of a lady and her son was reported at Police Station Miran Sahib and accordingly a missing report was entered into this police establishment.

To trace out the mother-son duo, a team from Police Station Miran Sahib led by SHO Inspector Bhopinder Singh was constituted under the supervision of SDPO RS Pura Nikhil Gogna.

The team did strenuous efforts and with the help of technical assistance along with human intervention, traced out missing mother-son duo.

After completion of legal formalities, the traced-out lady along with her son were handed over to legal heirs and the missing report was closed accordingly.

## Trucker arrested for smuggling bovines

## Couple impersonating as IPS, IAS officers arrested in Srinagar

**Srinagar:** Police Monday arrested a couple impersonating as IAS, IPS officers in Srinagar district.

The police said in a statement that a written complaint was received by this Police Station Sadder to the effect that fraudulent activities of two individuals impersonating themselves as IPS and IAS officers have come to fore. They have cheated a number of people on pretext of giving them



jobs etc. The accused individuals have been identified as Manmohan Gangoo, son of Late Gardari Lal Gangoo, resident of Barnai, Jammu at present Baghat Srinagar who was Suspended HC and his wife Ayoush Koul.

On receipt of this application an FIR 73/23 was registered under sections 419, 420, 468, 471, 170, and 467 of the Indian Penal Code. Immediate action was taken and the accused individuals have been apprehended. Investigation into the matter has been initiated to establish the veracity of the other allegations and for collection of evidence.

As part of this ongoing investigation, certain recoveries including money and jewelry have been made and some electronic gadgets have been seized on spot in front of Executive Magistrates. Many fake orders have been found from these digital devices including fake order of his own induction into IPS.

## Famous youtuber Amir Majid's car seized for RC contravention, tinted glasses

**JAMMU:** Police on Monday seized famous youtuber Amir Majid's car for RC contravention, tinted glasses.

As per details, during regular Challaning at Narwal, a vehicle (GJ04CR 9995) was found plying on the NHW with Tinted glass (Black Film). The said vehicle was stopped by the Challaning officer on spot and asked for showing vehicle documents. During document checking it was found that the said vehicle owner has contravened vehicle Registration Certificate and hence the vehicle was seized against contravention of R.C and plying with Black Tinted Glasses under relevant provisions of M.V Act. Later on it was also found that the vehicle belongs to Amir Majid a YouTube Blogger.



## Police files charge sheet against top heroin supplier from Punjab

**SAMBA:** The Jammu and Kashmir Police on Monday filed a charge sheet against a suspected top heroin supplier from Punjab in a court in Samba district, an official said.

The charge sheet against Jugraj Singh alias Yodha of Amritsar in Punjab was filed in a case related to the seizure of heroin along with Rs 16.17 lakh in cash from the district's Ghagwal area some months ago, the official said.

Singh was arrested from Amritsar by Jammu and Kashmir Police following a series of raids in Punjab after the registration of an FIR against him under the Narcotic Drugs and Psychotropic Substances Act. He is currently lodged in jail, the official added.

Operating from Punjab, Singh allegedly supplied huge quantities of heroin to local suppliers in Samba and adjoining dis-
