

Subject: Notices to the eligible industrial units for completing online applications for registration under New Central Sector Scheme for Industrial Development of Union Territory of Jammu & Kashmir.

This is to inform all the Industrial Units that the Ministry of Commerce & Industry, Department for Promotion of Industry and Internal Trade, Government of India has announced New Central Sector Scheme for Industrial Development of Union Territory of Jammu & Kashmir vide Notification No. F. No. 1(1)/2020-SSS dated: 19.02.2021. In this context, most of the industrial units have filed their application online (www.jknis.dpiit.gov.in) for grant of registration under the scheme to avail the benefits envisaged in this policy. It is worth to mention here that the many Industrial units are not responding to the online queries raised by District Industries Centre, Samba relating to their online application and their applications have already been returned for completion of the same. But, still many industrial units have neither uploaded all the requisite documents nor responded to the queries, due to which this office is not able to process the applications further for registration. As such, it is advised to all the unit holders to visit the portal and respond to the queries raised by this office and upload the requisite documents within 15 days' time so that the applications can be verified and recommended for registration, failing which, their case applications shall be placed before the Secretary Level Committee (SLC) for decision thereof.
