

General Assembly Elections: DEO Kishtwar holds online interactive meeting with BLOs

KISHTWAR: The Deputy Commissioner Kishtwar, Rajesh Kumar Shavan, who also serves as the District Election Officer, today convened his maiden interactive meeting with all the Booth Level Officers (BLOs) of the district through online mode.
